#### Citizen's forum

Tom Linell, of Sawmill Lane, advised that the City of Lebanon is in the midst of producing a bicycle & pedestrian plan. He said would like to see connectivity of various paths that intersect at the Enfield/Lebanon borders, specifically County Road and Shaker Mountain. Mr. Linell said his efforts to relay his ideas to Lebanon's Pedestrian & Bicycle Advisory Committee and Conservation Commission have been unsuccessful. He asked the Enfield Conservation Commission to get involved. Mr. Linell said the Rail Trail cannot be counted on for recreational use in the long run. Now is the time to plan for alternatives. GREEN advised Mr. Linell that the Commission was unable to act on his request due to the absence of a guorum. His request will be discussed at their next meeting.

Mr. Linell referenced a newsletter published by the Upper Valley Trails Alliance that mentioned projects being done in Enfield. He asked what those entailed. Schneider said he was unaware of any specific Alliance sponsored activities other than a moonlight hike they are hosting in Enfield.
