Enfield Conservation Commission Public Works Facility, Enfield Meeting of January 7, 2016

Chairman Strickland called the meeting to order at 7:03 p.m.

Review of November 2015 minutes: A motion was made by Ms. Hagerman to accept the November 2015 minutes as written. This was seconded by Ms. King and the motion passed, with Ms. Hagerman abstaining.

Old Business:

Conservation Commission Transfer of Funds:

A motion was made by Ms. Hagerman to officially transfer \$5011.41 from the Conservation Fund for expenses at the Harris Brook Scenic Area. This was seconded by Ms. King and the motion was unanimously approved.

Sewer Extension Project:

A motion was made by Ms. King that the Conservation Commission will support a project to extend the sewer line from Shaker Village to Lakeview. This was seconded by Ms. Hagerman and the motion was unanimously approved.

Upper Valley Land Trust Purchase:

- A motion was made by Ms. King that the Conservation Commission supports in principle the Upper Valley Land Trust's (UVLT) pursuit to purchase 995 acres west of Route 4A. This was seconded by Ms. Hagerman and the motion was unanimously approved.
- A motion was made by Ms. Hagerman that, pending legal approval, the Conservation Commission make a contribution in the amount of \$2,000 from the Enfield Conservation Fund to the Upper Valley Land Trust (UVLT) toward acquisition of the said 995 acres west of Route 4A. Ms. King seconded and the motion was unanimously approved.

Winter Hike:

A winter hike has not been arranged.

Wildlife Talk:

Ms. Green has contacted potential speakers, with Bill Warren possibly presenting a program this spring entitled "Fuel for your Body, Food for the Trail."

New Business:

Land Acquisition Capital Reserve Fund:

Kurt Gotthardt spoke of the history of the Land Acquisition Capital Reserve Fund. These funds can only be used for the purchase of easements and/or land for conservation, recreation or other public purposes. There is some ambiguity to the meaning of this wording. John Roe of the Upper Valley Land Trust (UVLT) interpreted this as not meaning the land needs to be owned by the Town, just that the funds be used for conservation purposes. Mr. Gotthardt stated the Enfield Selectboard feels the Town needs to be the owner of the easement or the land itself, not a third party. Clarification of the Fund guideline wording is necessary and this can be accomplished by obtaining a petition warrant article with 25 signatures. Mr. Gotthardt proposed creating such a warrant article and requested the Conservation Commission's support of this endeavor.

Ms. Hagerman made a motion that the Conservation Commission support construction of a warrant article to reword the Land Acquisition Capital Reserve Fund guidelines to allow donation to a nonprofit conservation land trust for acquisition of land or easement within the town of Enfield. Ms. King seconded the motion and the motion unanimously passed. Mr. Gotthardt will proceed with obtaining the signature warrant.

The Conservation Commission supports an expenditure from the Land Acquisition Capital Research Fund to the UVLT for purchase of the 995 acres west of Route 4A.
