- Update on Shaker Bridge lights LED and dark sky compliance
- * Kim provided the recommended light fixture spec sheet to Alisa to review with the selectboard
- * ACTION: Wendell will suggest to the MLA that they put an educational piece in their newsletter about light pollution and specifically ask people to review their private lights that are shinning across a large section of lake.
- Update from LES (local energy solutions conference Kim/Phil)
- * Phil suggested we look for opportunities for saving energy for low income households. Energy reduction is a quick ROI for most people. Can EEC help this demographic?
 - * Kim went to sessions on how to finance projects through town budgets.
- Update on Energy Chapter (Mike McCrory couldn't make it to this one)
- Energy Committee's 2012 Project
 - * Wendell suggested that we look into Power Purchase Agreements as a way to help businesses and home owners get solar without shelling out a lot of money up front. Maybe there would be enough interest to start a co-operative energy company in Enfield (Enfield Energy Coop), and we can figure out ways to generate local energy for the town (starting with the bridge lights and micro-hydro).
 - * Phil suggested we might be able to harness the summer sun to pelletize brush and debris that residents already dump at the DPW from fall/winter/spring clean ups. Then provide pellets to those residents (as well as others) to heat homes in the winter. If this can work, it would create a market for cleaning brush off properties and it would be an inventive use of our extra solar energy from the sun providing heat in the winter.
 - * Richard suggested that we create an Energy Caravan Day -- where all interested parties would travel from one local renewable energy home to the next and give the home-owner a chance to explain what they have done and a chance for questions. This could be a good way for us to learn about a variety of projects and for people who are thinking about renewables to ask a lot of questions.
