- o PD Electrical usage Meeting with Chief Crate
- Richard, Larry and Kim got into the PD with a current meeting and checked all the circuits in main electrical panel. There are 2 circuits with more than 1.5 Amps constantly. They are labeled "Emg Generator" and "Outdoor wall pack".
- Need to investigate the generator and options for reducing or removing the 7.5A. And find out if the outdoor wall pack is related to the generator.
- Action: Kim will follow up with Chief Crate as to what "outdoor wall pack" is; Larry will try to determine if something associated with the generator like extra heating.
