Melissa attended Lioness dinner as a guest. It was a very good experience. Melissa and Shirley attended a Town Strategic presentation — What do people expect from their library? How will facilities be represented in the process? All groups have their wish lists, but nothing on the plan at this point about buildings. Renovations vs. new buildings vs. multi-use buildings

Regarding computer consulting, Melissa contacted Symquest and asked about IT from the company. EPL could continue to use our current IT guy (not very timely), or we will go to another group.
