Appendix A, Additional Definitions

"SES" – An acronym that shall mean Solar Energy Systems

"NH PUC" - an acronym that shall mean New Hampshire Public Utilities Commission

"Solar Array, Residential" shall mean an array whose generated electricity is used to offset that of the individual's residential electrical use, through NH PUC net-metering program.

"Solar Array, Community" shall mean an array whose generated electricity is used to offset that of the community of meters as defined in the NH PUC community net-metering program. Systems are less than 100kW in size.

"Solar Array, Commercial" shall mean an array whose generated electricity sold on the wholesale energy market, not part of a net metering program.

Article IV, Regulation of uses:

401.1 R1 add: V. Residential and Community Solar Array

401.2 R3 add: W. Residential and Community Solar Array

401.3 R5 add: W. Residential and Community Solar Array

401.4 CB add: W. Residential, Community, and/or Commercial Solar Array

401.5 C/I add: Q. Residential, Community, and/or Commercial Solar Array

401.6 Route 4 District

By-Right Uses add:

Commercial solar Array (3)

Notes: (3) Shall be located 100 or more feet from Route 4.

Site Plan Approval:

Site plan approval by the Planning Board must be obtained for any Community or Commercial Solar Array.
