### **Minutes of February 26, 2014:**

- Motion to approve the Minutes of January 8, 2014 came forward from Kurt Gotthardt with a second from John Kluge. Motion carried.

### **Selectmen's Report:**

John Kluge – Selectmen's Representative informed the board that the selectmen are preparing for the annual Town Meeting. Town Reports have been printed and delivered and should be in your mailbox within the next day or two.

### **Public Hearings:**

- I. New Hampshire Electric Coop has requested permission to cut trees on Boys Camp Road, which is a designated Scenic Road in Enfield. In accordance with RSA 231:158 a Public Hearing will be held whereby the Enfield Planning Board will consider the request for acceptance or rejection.

Planner Osgood noted that the trees have been flagged and he has viewed them and compared the plan against the field flagging. No discrepancies were found. Public notices have been in the local paper two times. Notification to abutters is not needed. Posting of this hearing was posted in three places. Planner Osgood sees no issues to inform the board on this hearing.

Mr. Roger Sawyer, General Foreman for Trees, Inc. was in attendance for presentation. Trees, Inc. was sub contracted by NH Electric Coop to remove the trees noted on the plan on our scenic road Boys Camp Road.

Kurt asked about the distance of cutting and was told it is sparse across two miles.

John Kluge made a motion to accept this request with a second from Tim Taylor. Motion carried.

**Communication:** No items discussed

**Informational Items:**

Ordinance Updates. Planner Osgood has been working on the items noted in the memo of 11-13-13. Master Plan needs substantial work. Requests to the Conservation Commission and other Town committee will be made to assist the updating process.

Enfield Outing Club wants to build an additional range – they will need to cut trees. This is Non-commercial – private membership. They will attend a future meeting to discuss the details.

CDFA Grant request – Food Coop. Application has been filled out however, Planner Osgood has not heard back from them.

March 5, 2014 – Bruce Waters, Realtor will be speaking about commercial and residential real estate in the area. This meeting will be held at the DPW.
