2. Discuss FY15 Budget (YTD)

The FY15 budget appears to be on track at this time.

3. Receive FY16 Budget and Start Budget Discussion for Upcoming Year

The FY16 Budget booklets were distributed to the Committee and the initial budget appears to be well over the Proposition 2 ½ Levy Limit. This is driven mainly by proposed capital expenses and increases to the MERSD and Vocational School budgets.

The budget presented is carrying a 3.8% increase for MERSD, but this number may be too low based on discussions with school officials. For several years, the School Committee has used Reserve funds to cover expenses and reduce the assessment to the member towns. However, their Reserves are dwindling and they would like to stop this practice in FY16. Additionally, they are looking to address the enrollment increases over the past few years that have created class size issues in many areas, particularly at the Middle School.

Enrollment at the Vocational School has increased dramatically, with the number of students doubling over the last few years. Based on discussions with school officials this trend is likely to continue.

Over the next few weeks, the Committee will address various ways to reduce the FY16 budget and bring the final amount under the Proposition 2 ½ Levy Limit. There is additional levy capacity available from prior years that may be used to reach this goal.
