# Appointments

7:15 pm, Atty. Watsky requested appointment re: Karen McNiff, property, parcel of land near 90 Apple Street: Atty. Watsky and Mr. Christiansen, PE, representing Atty. Zide and the Hodges in attendance. Atty. Farrah, for Ms. McNiff, in attendance. Mr. Ottenheimer, sanitarian for Ms. McNiff, not able to attend. Atty. Zide arrived late.

Attorney and engineer, for abutters of the McNiff property, requested the appointment, and asked that the Board rescind the wastewater disposal system design plan for this property, approved 7-5-07, and the disposal works construction permit, dated 5-22-12. They contend that the permit was issued in error, with significant errors in the plan in violation of Title 5, without Title 5 variances needed if those differences from the Title 5 requirements were intended. Often referenced at this meeting, was a plan, dated 12-23-10, for this property, not previously submitted nor approved by the Board, and a letter, dated 4-11-13, not previously received by the Board, both now included in the file.

Atty. Farrah, representing property owner McNiff, pointed out to the Board that there is a clear mechanism indicated in Title 5, that any person aggrieved by any issuance by a local approving authority may appeal the decision to any court of competent jurisdiction, and not the Board of Health. He further stated that there are no errors made on the approved design plan and concludes that there is no mechanism indicated in Title 5 for the Board of Health to amend a decision previously made about issuance of a disposal system construction permit. Atty. Farrah asked that Mr. Ottenheimer, who was away on a long planned family vacation, be allowed to meet with the Board at a future date should additional information regarding the septic plan be required.

Dr. Driscoll concluded the appointment, stating that the Board will take this under advisement.

7:30 pm, Eric Corwin re: enforcement order 199 R John Wise Avenue: Mr. Corwin in attendance. Discussion: options for Mr. Corwin to achieve compliance. He will work with the Health Agent and has submitted an application for soil testing. Further, an anonymous letter, dated 4/10/13, received 4-11-13 given to the Town Clerk for the Planning Board, with Cc to the Board of Health, is in the property file and a copy was made available to Mr. Corwin. He will work with the Health Agent and has submitted an application for soil testing.

Senior Center Podiatrist: A person who observed the practices of the podiatrist who currently conducts clinics at the Senior Center is concerned that; the podiatrist did not wear gloves when working on clients and he failed to wash his hands between clients as well as some other concerns. The Board asked Ms. Wozny to compose a letter notifying the Podiatrist of these concerns, which they will sign and Cc the Council on Aging.

153 Conomo Point Road, Foley/Town of Essex, Map 24, Lot 17: The DPW called stating they had discovered what looked like a cesspool with a missing cover and only a piece of wood covering it. The Town Administrator is proactively working with DPW to replace the missing cover as this is a town property for which there is no longer a lease. In the interim, the opening has been

covered with wood and weighted down to prevent access. The BOS with be notified of the corrective steps to be taken.

- Tracking of Housing, Food Service and Other Miscellaneous Board Issues
  - The question has come up as the whether a septic system that received a "conditional pass" on an inspection is mandated to connect to the public sewer if available, rather than perform a d-box or tank component replacement to convert the inspection to a "pass". Ms. Wozny consulted with DEP and it was their determination that if sewer is available, the only work to be allowed on the existing septic system is the leveling of the d-box. Any work requiring a permit, as in component replacement, requires connection to the public sewer, if available.
