- B. The informational meeting on the Town Building Committee held at the Senior Center on Oct. 5 was discussed.
  - 1. The Building Committee's conclusion to locate a new police station on the cemetery lot on John Wise Avenue is not a wise one.
  - 2. This is an historic early section of Chebacco/Essex
  - 3. The neighborhood characteristics will disappear; no one wants to live in a commercial area.
- 4. Not enough details are in the Request for Proposals to make accurate estimates of cost,
  - 5. There is not an adequate discussion of the Town Hall.
- 6. The "Wish Lists" of the Police & Fire Departments have not been pared down to reasonable requests.
