Mr. Silvia called the meeting to order at 6:30 p.m.

Dr. Bowcock motioned to approve the minutes of October 20, 2008. Mr. Murphy seconded. Vote was unanimous.

Dr. Bowcock motioned to approve the minutes of the October 20, 2008 executive session. Mr. Murphy seconded. Vote was unanimous.

Dr. Bowcock motioned to approve the minutes of October 29, 2008. Mr. Murphy seconded. Vote was unanimous.

LIQUOR LICENSE HEARING FAIRHAVEN CONVENIENCE STORE

Liquor License Hearing was scheduled for 7:00 p.m. to act on the application submitted by Nina Enterprises, Inc., d/b/a Fairhaven Convenience Store, 121 Sconticut Neck Road, James A. Casey, Manager. Mr. Silvia read the notice of hearing into the record. (See attached.) Attorney Stephen Swaye, representing the applicant, and the owner Mr. Shamsi, were in attendance. Mr. Silvia read letters from the Building Commissioner regarding parking issues and from the Health Agent indicating violations for keeping outof-code foods on the store shelves and haphazard storage. (See attached.) Attorney Swaye indicated the parking issues were corrected and Board of Health issues were addressed. Discussion ensued on the layout of the store. Attorney Swaye stated liquor will be stored behind a chain link fence and locked and alcohol will not be served before noon on Sunday. Mr. Silvia stated the Building Department and Board of Health must "sign off" on the application, as is the procedure for all liquor licenses. Also, workers' compensation insurance must be submitted. Dr. Bowcock motioned to continue the hearing to November 17, 2008. Mr. Murphy second. Vote was unanimous.

TAX CLASSIFICATION HEARING

In accordance with the provisions of Chapter 369 of the Acts of 1982, the Board of Selectmen scheduled a public hearing on the issue of allocating the local property tax levy among the five property classes. Notice of hearing, scheduled for 7:15 p.m., was published in the Standard Times on October 27, 2008. The Director of Finance/Treasurer, the Board of Assessors and the Board of Assessors Administrative Assistant were present. Mr. Silvia opened the hearing. The Treasurer recommended a Commercial Rate of \$16.51 and a Residential Rate of \$8.30. Discussion followed. Dr. Bowcock motioned to adopt a Residential Rate of \$8.30 per thousand and Commercial Rate of \$16.51 per thousand. Mr. Murphy seconded. Vote was unanimous. Tax bills are expected to be

mailed on November 14, 2008. The Treasurer/Director of Finance encouraged tax payers to either mail tax payments to the "lock box" or use the Town's web site to make payment either from a credit card or checking account.

COMMUNITY DEVELOPMENT STRATEGY HEARING

Community Development Strategy Public Hearing was scheduled for 7:45 p.m. The purpose of the hearing was to gather public input on the Town's FY 09 CDBG application. Mr. Silvia opened the hearing and read the notice of hearing into the record. (See attached.) Mr. Roth summarized the "2008 Fairhaven Community Development Strategy". (See attached.) Topics discussed were: housing, planning, infrastructure, economy, open space and recreation, cultural and strategy priority goals. It is recommended the "Target Area" remain the same: the Cushman Park neighborhood including the following priority streets: Green Street, Main Street, Middle Street, Spring Street, Park Street and Elliot Street. Discussion followed. Public comments will be taken until Friday, November 14, 2008. Hearing to finalize the strategy is scheduled for November 17, 2009 at 7:00 p.m.

Dr. Bowcock motioned to sign the contract, not to exceed \$4,800.00, with Caulfield Environmental, 243 Legate Hill Road, Leominster, MA for environmental services for the 2008 Community Development Block Grant. Mr. Murphy seconded. Vote was unanimous.

Director of Planning/Economic Development suggested the formation of a formal Advisory Committee.
