Selectmen's Meeting – June 22, 2009

Dr. Bowcock called the meeting, at the West Island Community Center, to order at 6:30 p.m.

Mr. Silvia motioned to approve the minutes of June 8, 2009. Mr. Murphy seconded. Vote was unanimous.

HURRICANE PREPAREDNESS

Hurricane Preparedness was discussed with department heads from the Board of Public Works, the BPW Superintendent, Fire Chief, Police Chief and Emergency Management Agency. Dr. Bowcock read a letter from Marc Jodoin, EMA Director, informing the Board several EMA volunteers recently passed the amateur radio exam. (See attached.) Residents were reminded that the Wood School is the primary shelter. West Island residents were advised if a decision is made to evacuate the Island, they should heed the warning and leave. If someone decides to remain on the Island, they should call the Police/Fire Department and leave their name, address and telephone number. Rescue personnel will not be on the Island during the storm. Residents were reminded hurricane passes are available at the BPW.

FIRE DEPARTMENT/POLICE DEPARTMENT

The Police Department received a 23 foot Boston Whaler from the U.S. Government, through a program that allots surplus government property to local law enforcement agencies. The current 25 foot Sea Hawk police boat was turned over to the Fire Department.

The Fire Department would like to declare their old 25 foot Boston Whaler Frontier with twin 200/hp Yamaha outboard motors surplus equipment. The Fire Chief reported the boat is up for sales and the department is accepting sealed bids. Mr. Silvia motioned to declare the old Fire Department boat surplus. Mr. Murphy seconded. Vote was unanimous.

EMERGENCY MANAGEMENT AGENCY
