Selectmen's Meeting – March 8, 2010

Dr. Bowcock, Mr. Murphy and Mr. Silvia were present.

Also in attendance was Jeffrey Osuch.

Dr. Bowcock called the meeting to order at 6:30 p.m.

Mr. Murphy motioned to approve the minutes of February 19, 2010. Mr. Silvia seconded. Vote was unanimous.

Mr. Murphy motioned to approve the minutes of the February 19, 2010 executive session. Mr. Silvia seconded. Vote was unanimous.

### DEDICATION OF L.D. ELDRED PAINTING

Albert Benac, Art Curator, presented the Town with the Lemuel D. Eldred etching "The Old Whaler", as the fifth etching in a set of six, created by the artist, of the whaling era in the New Bedford and Fairhaven Harbor. The gift was presented in loving memory of Kathleen C. Benac, by her husband Albert Benac, and children, Paul, Claudia, Kathleen and Monica. The etching has been completely refurbished and now hangs in the Tax Collector's Office. The Board thanked the Benac family for their generous donation and expressed their condolences.

### LAND AND WATER CONSERVATION FUND GRANT HEARING

Public Hearing was scheduled for 7:00 p.m. to seek public comment on the Town's FY 2010 Grant Application for the Land and Water Conservation Fund. The Town, in partnership with the Coalition for Buzzards Bay, will apply for funding for the purchase of approximately 59 acres off New Boston Road. Director of Planning and Economic Development was in attendance and explained the proposed grant application. (See attached.) On March 4, 2010, the Community Preservation Committee voted to recommend to Town Meeting to fund a grant match of \$215,000 to purchase the property. If a grant application is approved, reimbursement from the State would be not less than \$200,000. Total purchase price is \$415,000. No funds will be expended, unless the Town is eligible for grant reimbursement in the amount of not less than \$200,000. Mr. Murphy motioned to submit the grant application and authorize the Chairman to sign any and all necessary documents. Mr. Silvia seconded. Vote was unanimous. Application is due March 31, 2010.

### VIDEO EQUIPMENT

Meaghen Blasingame was in attendance and reviewed a list of video equipment to be purchased. (See attached.) Total price is \$13,979. Funding will come from Comcast funds set aside for equipment purchase. Mr. Murphy motioned to support the purchase of video equipment in the amount of \$13,979. Mr. Silvia seconded. Vote was unanimous.

#### NATURAL RESOURCE DEPARTMENT

Tim Cox, Shellfish Warden, discussed proposed changes to Shellfish and Dredge Boat Regulations. (See attached.) Discussion followed. Mr. Cox will clarify the proposed changes and they will be placed on the March 15, 2010 agenda.

Mr. Cox stated the new owner of Bella Vista Island blocked off the road and Round Cove and Senior Cove are now only accessible by the water. Since the 1970's, the Town has maintained the road and it was used by the public. Town Counsel will be asked to look into the matter and to send a letter to the owner of Bella Vista.

Mr. Silvia, the Town's representative on SRTA, reported SRTA will re-introduce two bus routes in Fairhaven, that were eliminated several years ago, to determine if there is a demand for service. The routes are: Route 6 to Mattapoisett and Main Street to Acushnet.
