Selectmen's Meeting – February 28, 2011

Mr. Silvia motioned to approve the minutes of February 14, 2011. Dr. Bowcock seconded. Vote was unanimous.

#### TREE WARDEN

#### NEW SCHOOL BUILDING COMMITTEE

Chris Bunnell, Chairman of the New School Building Committee, and David Gonsalves, a member of the New School Building Committee and School Committee were in attendance. Mr. Bunnell asked the Board of Selectmen to endorse the New School Building Committee's vote to build a new school at the Wood School site, which would be a model school similar in design to the East Fairhaven School. The Committee voted 6-2 in favor of the new school at the Wood School site. The School Committee also voted in favor of the Wood School site. Discussion followed. Mr. Silvia motioned to endorse the recommendation of the New School Building Committee, already endorsed by the School Committee. Dr. Bowcock seconded. Vote was unanimous.

At the next School Committee Meeting, Mr. Gonsalves will ask the School Committee to discuss future uses for the Rogers' School and the Oxford School.
