Dr. Bowcock made the motions for "recommendation" for numerous Annual Town Meeting Articles and Special Town Meeting Articles. Mr. Silvia seconded. Vote was unanimous. (See attached.)

### WAYNE STREET

The reconstruction and triple stone sealing of Wayne Street from Sconticut Neck Road easterly to the end was discussed. At the March 14, 2011 Selectmen's Meeting, residents of Wayne Street discussed the poor condition of the street; pot holes, mud when it rains, icy in the winter and dusty when there is no rain. They stated that at Town Meeting, the Board of Public Works will support hard surfacing Wayne Street. The petitioners asked for the Selectmen's support and the Board voted to place an article on the Special Town Meeting Warrant to reconstruct and triple

stone seal Wayne Street and funding is to come from the Potter Street Article passed last year. The Board stated only one year round resident uses Potter Street and that resident is a member of the Board of Public Works. Also, Potter Street is not on SRPEDD's list of streets that need to be surfaced/re-surfaced. Historically, The Selectmen and the Finance Committee make recommendations for Road Work, not the Board of Public Works.

#### NEW ELEMENTARY SCHOOL

The Board reported that last Friday, March 25, 2011, the School Superintendent, Executive Secretary, Chairman of the New School Building Committee and members of the New School Building Committee attended a MSBA meeting with the architect and project manager for an update on the new school project. MSBA requires a complete summary of the project by the end of this week and on April 15, 2011, MSBA will give their report. A letter from Jennifer Bishop and a petition from Town residents requesting an "immediate hold be placed upon the School Building Committee's (SBC) decision to move forward with the current elementary school consolidation plan" were discussed. They are asking for a fuller exploration of ways to preserve/maintain the Wood and Rogers School and keep a smaller class size. Discussion continued on class size, the two school option vs a new elementary school. The issue will be placed on the April 4, 2011 agenda.

### OTHER MATTERS

In the near future, an appointment will be scheduled with representatives from West Island to discuss bathroom facilities at West Island beaches.

The fund raiser held at the Manjuro House this past weekend to assist victims of the devastating earth quake in Japan was very successful. The Board reported this event is just the beginning of the fund raisers.

The Board congratulated former Fairhaven Police Office Walter Baiardi on being named "State Police Officer of the Year".

Mr. Murphy read the "Connecting the Dots" notice announcing that Donna Palomba and Dateline NBC will "connect to tell the story of her year journey to achieve justice after surviving a sexual assault." Ms. Palomba will be at the Seaport Inn and Marina, 110 Middle Street on April 11, 2011 from 7:00 – 8:00 p.m. (See attached.)
