Also in attendance was Jeffrey Osuch.

Mr. Silvia called the meeting to order at 6:30 p.m.

Dr. Bowcock motioned to approve the minutes of June 20, 2011. Mr. Silvia seconded. It was so voted.

RIVERWALK TRAIL PROJECT

Nancy Durfee from SRPEDD was in attendance and briefly explained the Riverwalk Project planned for waterfront areas of New Bedford, Acushnet and Fairhaven. (See attached map.) The project is in the very preliminary stages of development, but the plan is to create a walk way/bike path along the waterfront connecting all three communities. Boat access to the water at numerous locations is also planned. Funding will come from the Harbor Trustees.

GOVERNMENT ACCESS DEPARTMENT

Meaghen Blasingame, Government Access Director, was in attendance and submitted a proposal to increase the operating budget and purchase new equipment. (See attached.) An operating budget of \$16,000. is requested and \$23,000. is needed for new equipment. Ms. Blasingame suggested using the East Room as a second meeting room and mini studio. Discussion followed. Dr. Bowcock motioned to approve the requests. Mr. Silvia seconded. It was so voted. Funding to come from Comcast Franchise Fee payments.

BOAT RAMP & WATERFRONT RECREATIONAL PROPERTY COMMITTEE

Shellfish Warden Tim Cox, members of the Boat Ramp and Waterfront Recreational Property Committee and Dough Cameron from the MA department of Fish and Game were in attendance to discuss the installation of a fishing pier at Hoppy's Landing. The location has not yet been determined. Mr. Cameron stated the State would include the existing boat ramp and floating dock into the agreement. The Town would be responsible for day to day maintenance and the State would handle any large repairs. The pier would be must be open to the public. A fee could be charges, but must first be approved by the State. Discussion followed. Dr. Bowcock motioned to request a proposed Land Management Agreement from Mr. Cameron for the project. Mr. Silvia seconded. It was so voted.

BICENTENNIAL COMMITTEE

Natalie Hemingway, Wayne Oliveira and Gerry Payette, members of the Bicentennial Committee, were in attendance to promote the sale of the "Fairhaven Bicentennial 1812-2012 Souvenir Calendar". Ms. Hemmingway stated every part of Town is represented. Calendars sell

for \$15.00 each and are available at numerous locations throughout Town. Mr. Oliveira briefly summarized events planned for the Bicentennial Celebration. Events include a Bicentennial Ball, the Father's Day Road Race, Homecoming Day Fair, a Fire Muster, a Maritime Day, Bicentennial Parade and the "Vietnam Memorial Moving Wall".

The Director of Finance/Treasurer submitted a request for approval to pay \$2,000. from the Bicentennial Account, as a deposit for the Vietnam Memorial Moving Wall. The Wall is scheduled to be on display in Cushman Park on July 4th. Dr. Bowcock motioned to approve the request. Mr. Silvia seconded. It was so voted.

PERSONNEL BOARD

Dr. Bowcock motioned to table the requests until the next meeting, when Mr. Murphy is present. Mr. Silvia seconded. It was so voted.

Dr. Bowcock motioned to sign the "Contract for Public Health Nursing" by and between the Town of Fairhaven, Board of Health and Community Nurse and Hospice Care, Inc. in the amount of \$17,000. Mr. Silvia seconded. Vote was unanimous.

COUNCIL ON AGING

Dr. Bowcock motioned to appoint Lindsay Gordon a full member of the Council on Aging. Mr. Silvia seconded. It was so voted. (Term to expire May 31, 2012.)

HARBORMASTER

The Harbormaster submitted a request to carry over 10 vacation days and 40 hours of comp. time. Dr. Bowcock motioned to approve the request. Mr. Silvia seconded. Vote was unanimous.

MASSACHUSETTS SCHOOL BUILDING AUTHORITY

CDBG 1 YEAR ACTION PLAN COMMENTS
