Selectmen's Meeting – October 17, 2011

Mr. Silvia, Dr. Bowcock and Mr. Murphy were present.

Also in attendance was Jeffrey Osuch.

Mr. Silvia called the meeting to order at 6:30 p.m.

Dr. Bowcock motioned to approve the minutes of September 27, 2011. Mr. Murphy seconded. Vote was unanimous.

Dr. Bowcock motioned to approve the minutes of the September 27, 2011 executive sessions. (6:36 p.m. and 7:53 p.m.) Mr. Murphy seconded. Vote was unanimous.

Mr. Silvia amended the minutes of October 3, 2011 stating he voted in opposition to increasing dockage fees at Union Wharf "Lobster Basin" to \$1,200.00 per year. Dr. Bowcock motioned to approve the minutes of October 3, 2011 as amended. Mr. Murphy seconded. Vote was unanimous.

Dr. Bowcock motioned to approve the minutes of the October 3, 2011 executive session. Mr. Murphy seconded. Vote was unanimous.

BIKE PATH PLANNING COMMITTEE

Kenneth Pottel was in attendance to request the Bike Path Planning Committee be re-activated. Dr. Bowcock motioned to recreate the Bike Path Planning Committee. Mr. Murphy seconded. Vote was unanimous. Anyone interested in appointment may submit a letter to the Selectmen's Office.

JOHN POND

John Pond was present and discussed business and manufacturing in Fairhaven. He emphasized the need to attract new businesses. Brief discussion followed. Mr. Silvia stated manufacturing in Massachusetts is changing to a smaller scale. Fairhaven has Nye Lubricants, Brahmin Leather, several shipyards and tourism. These are all smaller scale manufacturers that bring money into Fairhaven. The Town also has a Fairhaven Businessman's Association that meets on a regular basis.

LIQUOR LICENSE HEARING RASPUTIN'S TAVERN, 122 MAIN STREET

A Liquor License Hearing was scheduled for Monday, October 17, 2011 at 7:30 p.m. pursuant to the provisions of Massachusetts General Laws, Chapter 138 §64 to determine whether Rasputin's Tavern, holder of a license issued under General Law Chapter 138 §12, to conduct business at the premises located at 122 Main Street, Fairhaven, Massachusetts has violated the provisions of said Chapter 138 and any rules and regulations promulgated under the authority of

that Chapter; and if such violation or violations is or are found to have occurred, whether such license should be modified, suspended or revoked. Mr. Silvia read the notice of hearing into the record. (See attached.) Ellen and Matthew Cebula, owners of Rasputin's Tavern, Attorney Joseph Michaud, representing the Cebula, Bar Manager Sarah Bland, Police Chief Myers and Sergeant Stephen Foster were in attendance. The Police Chief and Sergeant Foster testified that the Police Department is concerned with the management and operations of Rasputin's Tavern. Both stated numerous incidents have occurred ranging from fights, underage drinking, open containers and drinking on the streets outside the Tavern. These incidents disturb residents in the neighborhood and create problems with dispersing crowds at closing time. Chief Myers stated more than 60 calls/incidents had occurred during the past year and Rasputin's Tavern had more calls for incidents for assistance, than the other ten bars/taverns in Fairhaven. Attorney Michaud agreed the incidents had occurred. Attorney Michaud stated Rasputin's Tavern has become a popular establishment and the owners wanted it to be a place where people want to frequent safely. He stated the owners have begun to implement changes and improvements to address the Town's concerns. Some of the improvements included Premier Age Verification Magnetic Stripe scanners at the entry door and bar, security cameras inside and outside the Tavern, increased security at the entry door with "roaming" security outside the Tavern, and a "zero" tolerance policy for disruptive people. Discussion followed. The Board of Selectmen agreed to allow a trial period thru the end of December to determine if the improvements are working. Chief Myers will be asked to report back in December, as to the number of incidents that have occurred during the last quarter of 2011. The Board also requested a letter from Attorney Michaud outlining the proposed improvements and when changes/these improvements will occur.
