Fairhaven Board of Selectmen February 22, 2012 Meeting Minutes

Chairman Silvia called the meeting to order at 6:33 p.m.

ACTION:

The Board picked a cover for the Town Report. The picture, which depicts the corner façade of Town Hall, will appear on the cover of the 2011 Annual Town Report, and was taken by resident Frank Rezendes. Another photograph by Mr. Rezendes, depicting the front façade of Town Hall with Bicentennial banners, was selected for the 2012 Annual Town Report.

The Board acknowledged an Animal Shelter donation amount of \$41,845.91 from the estate of Gladys Brant. The Board was appreciative of the donation.

The Board then approved the use of the Town Hall auditorium for the Delano Kindred Family Gathering, scheduled through the Tourism Department for September 14, 2012. The Board voted to approve the use and waived the rental fee for the non-profit gathering, with the understanding that the group will pay an hourly fee to supply a janitor for the event. Dr. Bowcock motioned, Mr. Murphy seconded. Vote was unanimous. (3-0).

The Board then fulfilled a request from the Natural Resources department by appointing Katelyn Daignault to the position of Deputy. Dr. Bowcock motioned, Mr. Murphy seconded. Vote was unanimous. (3-0).

The Board voted to sign the final draft of the Collective Bargaining Agreement between the Town and Clerical Union, as approved by the February 15, 2012 Special Town Meeting. Dr. Bowcock motioned, Mr. Murphy seconded. Vote was unanimous. (3-0).

APPOINTMENTS:

The Board met with Gerri Frates at 6:45 p.m. to ask the Board to have the Town resume paying health benefits for a full-time Social Day Benefits worker at the Council on Aging. Currently, the Social Day program is not making enough to cover the cost of health care for the employee, and the Town covered the cost in the past for five years. This year, the Social Day program had to pick up the cost of the insurance. Mr. Murphy asked why the Town had covered it in the past but had dropped it, and Mr. Osuch speculated that it had probably been a mistake that was found and corrected, because the Social Day program is supposed to be self-sustaining.

Ms. Frates appealed to the Board, saying that the program is doing everything possible, including fundraisers and cost-cutting, to keep up with costs, but it is running this year in a deficit. She said it would help the program if the Town picked up the insurance cost.

There was some confusion as to whether the Social Day program was considered a grant-based program or partially Town-funded. It was determined that the matter would have to be investigated further before any action could be taken.

In a second appointment with Fire Chief Timothy Francis, the Board received an overview of the proposed Fiscal Year 2013 Fire Department budget. Chief Francis said that the proposed budget of \$1,734,015 reflected a \$27,831 increase, \$19,931 of which was contractual and out of his control.

The Fire Department's equipment request for this year is for a new ambulance, he said. Proposed Article 49 asked Town Meeting members to consider \$220,000 for a new ambulance. Chief Francis said that instead of trading in the older ambulance, he would like to keep it as a third ambulance for back-up. Last year, he said the department had to call mutual aid 40 times and missed out on revenue from those calls. Chief Francis said that the ambulance is in good condition considering its age, and there is no body rot on it. Moreover, he believes that having a third ambulance will allow the Fire Department to provide inter-facility transportation to the Southcoast Cancer Center in Fairhaven, thereby creating a new source of revenue for the Town.

Ambulance trips are billed at about \$400-500, Chief Francis said. More revenue from the trips can be acquired if the Fire Department raises Medicare rates.

Additionally, Chief Francis said that a mandatory radio narrow banding upgrade was rendered less expensive to the Town by a grant acquisition. The Town is now responsible for \$9,232 of the total, he said, instead of \$77,000. Chief Francis credited Earl Faunce for volunteering his services in the grant writing and subsequent acquisition. The Board praised Mr. Faunce.

The Fire Alarm Department is taking the pager update in "small bites", said Chief Francis, with FY13's requested amount being \$5,119. Fire Alarm Maintenance will see a FY13 increase of \$708, all of which is contractual.

The Fire Alarm Department is down to two master boxes in Town and the rest is all wireless, said Chief Francis. It will take a couple years to get the rest of the wires down. Atlas Tack, c/o Great Northern Industries, has not done anything to upgrade their fire box system, despite repeated prompting, said Chief Francis.

The Board thanked Chief Francis for his presentation.

At 7:20 p.m., the Board conducted a Public Hearing for an increase of cars at Getty, located at 371 Huttleston Avenue. Applicant Hatem M. El Rifai was represented by Attorney Robert Perry. The applicant requested to amend the Class II Car Dealer's License he currently holds to increase his vehicle limit to 14 spaces for used cars.

Atty. Perry said that the proposed 26 spaces would include six (6) employee spaces at the rear of the building and six (6) customer spaces at the westerly side of the building.

A total of six abutters were notified of the hearing, and registered mail receipts were on hand. No one in the audience spoke regarding the application.

The Board did acknowledge a letter from Louise Baptiste Jr., owner of RRR Auto Sales, Inc, located across the street from Getty. In his letter, Mr. Baptiste protested the car increase application, claiming that Mr. El Rifai was in violation of his current car limit, and Mr. Baptiste offered photos of 12 cars lined up on the Grinell Street side of the Getty lot. Getty's current permit allows no more than five (5) cars in the lot for sale.

Mr. El Rifai claimed that the photo Mr. Baptiste offered as evidence was an old photo taken in 2009, and he is currently in compliance with his license.

In correspondence accompanying the application, Building Inspector Wayne Fostin said suggested the business could sustain a 10 car limit. Town Planner William Roth said that the application may require a Special Permit from the Planning Board.

Atty. Perry claimed that a previous business had had 15 spaces on the site. He said that his client would be willing to "stripe" the parking spaces.

Mr. Murphy said that he wanted to speak with the Town Planner before proceeding with the application. The Board agreed that they needed to discuss the matter further with the Town Planner and the Building Inspector. The Board voted to continue the hearing for March 19, 2012, at 7:00 p.m. Dr. Bowcock motioned, Mr. Murphy seconded. Vote was unanimous. (3-0).

In a fourth Appointment, the Board met with Harbormaster David Darmofal and Shellfish Warden Timothy Cox to discuss the FY13 budget for the Natural Resources Department.

Mr. Darmofal told the Board that grants have allowed the Natural Resources Department to obtain a pump-out boat and other equipment. He expressed concern that the department's equipment will not be properly maintained and that safety services for boaters could be seriously impacted with a two (2) percent operating budget cut. He said that his department has been mindful of costs and has only purchased necessities.

The two sources of revenue for the department are Waterway Fees and Boat Excise Taxes, said Mr. Darmofal. He thought that more operating funds for the Natural Resources department should come from the Waterways Account, and that the Board should consider increasing the Waterway Fees to meet the demands of the Natural Resources department.

Mr. Osuch reminded the Board that the Town would have to pay for 25 percent of the Causeway dredging project and that those funds would have to come out of the Waterways Account.

The Board thanked Mr. Darmofal and Mr. Cox for their presentation.

CORRESPONDENCE:

The Board read a letter from resident Carol Murchie, regarding a tree at 25 Union Street. As expressed in earlier correspondence, Ms. Murchie said that she believed it was the Town's

responsibility to trim the tree, as the tree's limbs and branches crossed over a public way. Mr. Osuch maintained that Town Counsel's opinion was that the tree's trunk had been planted on private property and was the homeowner's responsibility. The Board had no comments and took no action.

The Board received a letter from Francis McGuirk regarding two parcels of land on Sconticut Neck that Mr. McGuirk and his sister may be interested in donating the land to the Town. Mr. Osuch said that the Board would have to check with the Assessors' office to check on liens and whether or not the lots are buildable.

The Board also read a letter from Animal Control Officer Cat Mindlin, indicating that a previous letter regarding dog bites that had occurred at 26 Fort Street had been for informational reasons only and that she had not meant for the Board to hold a public hearing. The Board acknowledged the letter, but decided to proceed with the dog hearing.

Fairhaven Improvement Association Homecoming Committee Chairmen Angela and Eric Dawicki submitted a letter to the Board, asking permission to hold the annual Homecoming Fair on Saturday, June 30, 2012, with vendors arriving at 6:00 a.m. and the final clean-up occurring at 5:00 p.m. Past-President of the Improvement Association, Chairman Sylvia, recused himself from the vote. The Board voted to approve the Fair. Dr. Bowcock motioned, Mr. Murphy seconded. Chairman Sylvia abstained. (2-0-1). Chairman Sylvia returned to the meeting.

The Board voted to re-appoint Anne Carreiro to the position of full-time Town Accoutant. Dr. Bowcock motioned, Mr. Murphy seconded. Vote was unanimous. (3-0).

Mr. Osuch took a moment to recognize the birthday cards that the children of East Fairhaven and the Rogers School had sent to Town Hall for the Bicentennial Celebration, via their teacher Rita Campoli. The Board also thanked the children for the cards.

The Board reviewed Article 4 figures for recommendation at the Annual Town Meeting on May 5, 2012. The Board voted to make recommendations for Articles 3, 5, 8A, 8B, 10, 17, 18, 19, 20, 21, 22, 23, 25, 30, 31, 33, 47, 48, and 50. Dr. Bowcock motioned, Mr. Murphy seconded. Vote was unanimous. (3-0). The Board voted to make a recommendation for Article 27 C, Road Work for Pleasant St; Dr. Bowcock recused himself from the vote. Chairman Sylvia motioned, Mr. Murphy seconded. Dr. Bowcock abstained. (2-0-1) The Board voted to make a recommendation on Article 27 D. Dr. Bowcock motioned, Mr. Murphy seconded. Vote was unanimous. (3-0). (See **attachment A** for recommendations).

The Board voted to make recommendations for Article 4 Town Charges. Dr. Bowcock motioned, Mr. Murphy seconded. Vote was unanimous. (3-0). (See **attachment B** for Article 4 amounts).

The Board voted to enter Executive Session at 9:09 p.m. to discuss Worker's Compensation and potential changes to the Union health insurance program. Dr. Bowcock motioned, Mr. Murphy seconded. Vote was unanimous. Roll call vote: Mr. Silvia in favor. Dr. Bowcock in favor. Mr. Murphy in favor. (3-0).
