

Ms. Sturtevant motioned to approve the minutes, of April 12, 2011, April 25, 2011, May 2, 2011 – Executive Session, May 7, 2011 and May 7, 2011 – Executive Session. Mr. Freitas seconded. Vote unanimous.

#### IV. Appointments

### A. William D. Roth, Town Planner – Re: Middle/Main Street Culvert Replacement

Mr. Roth – I just wanted to give you an update. We bid the project and Pavao was the lowest bid. There were five bids. You have under your action items the agreement with GCG for the engineering. They are the ones who designed it. I will be the one running the project like the Block Grant even though this is Chapter 90.

Mr. Riley – GCG and Pavao have done excellent work.

Mr. Freitas – I would like to thank Mr. Roth for his work. We appreciate it.

Mr. Roth – The pumping station; they've already started the north engine. The south engine is offline. It's almost in place. Hopefully in a week or so it will be complete. One concern I have is the future of the roof. We'll have to find some funds for the roof and paint.

Mr. Haworth – This is a worthwhile project. There is no general fund money.

# A. Pavao Construction – Award Contract for the Middle/Main Street Culvert Replacement

Mr. Riley motioned to award Pavao Construction the contract for the Middle/Main Street Culvert Replacement in the amount of \$172,000.00. Ms. Sturtevant seconded. Vote unanimous.

# B. GCG Associates – Engineering Agreement for the Middle/Main Street Culvert Replacement

Mr. Riley motioned to award GCG Associates the Construction and Administration and Observation Services for the Middle/Main Street Culvert Replacement. Mr. Freitas seconded. Vote unanimous.

### C. Pavao Construction – Payment #1 Middle Street Roadway Improvement, Chap.90

Mr. Freitas motioned to pay Pavao Construction \$22,899.27 for the Middle Street Roadway Improvement Project. Mr. Riley seconded. Vote unanimous.

#### B. Matthew Paulson – Request for Leave of Absence

Mr. Paulson – I have accepted a job with the New Bedford Fire Department. I start Monday. I don't want to leave on bad terms. If I can't make it through I would like to come back. I enjoy working here.

Ms. Sturtevant – I know Matt. He has an excellent record as a worker. I don't have a problem with it.

Mr. Riley – I echo Kathy's statement that he is an excellent worker. His supervisor speaks very highly of him, but it's a matter of precedent. The question I have for the Board is concern whether or not anybody else requests this if we do grant this? He's applied and accepted a job somewhere else. In the interim we have to hire someone temporarily. That person gets the short end of the stick if he comes back. I'm torn. Six months is a long time.

Mr. Freitas – I don't have a problem with this.

Mr. Hobson – I'm on the borderline. He's leaving for a new position. My question is, do we post the job or hire someone from outside.

Ms. Tripp – You could post for a temporary operator and then hire temporary truck driver. After six months you would have to make that person permanent or let him go.

Mr. Hobson - How long have you been here?

Mr. Paulson - Nine years.

Mr. Hobson - I'll go along with it

Mr. Haworth – Matt is one of the best we have. You're good at what you do. I don't want to set a precedent. You've had a good career with the Town. I do think we should grant this as a onetime situation. What happens with seniority?

Ms. Tripp – I believe when if he comes back he would have to work double the time he was out to get his seniority back.

Ms. Sturtevant – Why six months?

Mr. Paulson – The academy ends July 22<sup>nd</sup>. After that it will give me a certain amount of time to be on a piece of apparatus and then if I don't like it then I could come back. I told John anything I can do for him I would come back and do.

Mr. Haworth read Mr. Charbonneau's letter regarding Matt.

Mr. Hobson motioned to grant Matthew Paulson a six month leave of absence from the Highway Department and wish him luck. Mr. Freitas seconded. Vote 4-1 in favor with Mr. Riley opposed.

#### C. Edward Fortin, Water Superintendent – Re: Project Updates

Mr. Fortin – There are two projects; the first is the Sconticut Neck Tank. At the one year inspection an issue came up and we had to drain the tank. About 40' up the paint chipped off.

Mr. Riley – How long will it be offline?

Mr. Fortin – A few weeks. Rockwood is paying for the inspection time. It's warranted for two years on that section. The other project is cement lining. The bids are due May 26<sup>th</sup>. It's from Main to Adams Street on Route 6. The water main will be cleaned and cement lined.

#### D. Demetrio Costa, J.L.C. Construction – New Drainlayer, Driveway Contractor

Mr. Costa submitted his third letter of reference to the Board.

Mr. Costa – I own an excavating company. I've worked in New Bedford, Fall River and Dartmouth. I've expanded my company. I have four employees. I also specialize in concrete.

Mr. Riley – I'm all set. His paperwork and insurance is up to date.

Mr. Freitas - All set.

Mr. Hobson - All set.

Ms. Sturtevant – My question is stamped concrete if you go to the part near the road, you need to get a waiver.

Mr. Haworth – In most cases that is eight feet from the street. Stamped concrete is an unapproved material.

Ms. Tripp – Stamped concrete is an approved material, but the homeowner needs to sign a waiver that in case there is any damage done to the part that's in the Town layout, they are responsible. We will not fix it for any reason.

Mr. Costa – Do you require a bond?

Mr. Haworth – No.

Mr. Riley motioned to approve J.L.C. Construction as a drainlayer and driveway installer in the Town of Fairhaven on a one job basis. Mr. Freitas seconded. Vote unanimous.

# E. Interview for Engineers for the Upgrades to Taber & South Street Pumping Station

#### 1. Thomas Jenkins, Ron Porter – Fay Spofford & Thorndike

Mr. Jenkins and Mr. Porter gave the Board a presentation regarding the proposed project.

Mr. Porter – We could have a design to you by mid October.

Mr. Jenkins – We designed those pumping stations.

Mr. Freitas – I know FS&T. They do an excellent job.

Mr. Hobson – If Mr. Freitas recommends them I think that's a good point.

Ms. Sturtevant – I agree. For us, in the past there have been no problems.

Mr. Riley – The design?

Mr. Jenkins – That list came from a report from Brown and Caldwell. We will discuss with the Town what to do.

Mr. Haworth – We've seen a lot of change orders from other firms. \$68,000 is that the real cost or not?

Mr. Jenkins – its \$68,000. We will not ask for extra money. We know you have a lot more work here. We want a long term relationship.

Mr. Riley – In 1991 on South Street, the general scope?

Mr. Porter – We designed and added a fourth pump.

Ms. Sturtevant – I agree with Linda.

Mr. Haworth – It's important that we way in on every avenue. FS&T is the low bidder.
