A. June 19, 2012

C. Bike Path Committee

Mr. Pottel – We have an overall plan that we'd like to see over the next few years. There are three areas; first is the Sconticut Neck crossing. We feel it can be done without a lot of money or resources. It needs to be very much improved. Also some sidewalk improvements to the new Wood School and connect to West Island. We'd like to see a shared right of way on Sconticut Neck road with lines painted on both sides.

Mr. Haworth – We tried to get funding for that but we were shot down at Town Meeting.

Mr. Pottel – We need cost information. We'd like to do some fundraisers.

Mr. Furtado – I can get you some figures.

Ms. Sturtevant – What about putting a barrel at Sconticut & David Drown as a trial thing? There are the ones that bend down.

D. Tom Jenkins, Ron Porter, Fay, Spofford & Thorndike – Re: Agreements

Mr. Jenkins – We submitted a fee for a comprehensive set of information for South and Taber Street. The documents are 90% when we were told we had to scope back and modify the drawings. Horizon came in and did some changes to the pump and there were changes to the existing conditions so we had to modify the drawings before we put it out to bid.

Mr. Haworth – Seems like we had a number and that number created a little bit of work which you were expected to do within that scope.

Mr. Hobson arrived at 7:10 p.m.

Mr. Freitas – I understand we had to step back because of Town Meeting. I think we've had problems with other engineers. I'd rather not go forward and really rather just not do it. You do really good work.

Mr. Jenkins - We have been in business over one hundred years. I'm going to take this value off the table. We want to work more with the Town and compromise. The project is ready to go out to bid. There is \$1,400 left to bill. I'll take that off the table and use it for construction services.

Ms. Sturtevant - That would be fine.

Mr. Riley – That's great that you will serve that to us in good faith. It's been a never ending project up the street. We do appreciate that. We'll accept the offer.

Mr. Furtado – I appreciate Tom's offer. We did change the scope.

1. Upgrades to WWTF Aeration Tanks

Mr. Jenkins – I was asked to submit a proposal for the aeration tanks to replace gates; design, bid phase services and construction phase services for \$79,800.00.

Ms. Schick – This was based on the scope two years ago.

Mr. Freitas motioned to approve the Aeration Tank improvements with Fay, Spofford & Thorndike for \$79,800.00. Ms. Sturtevant seconded. Vote unanimous.

2. Wastewater Management Plan

Mr. Jenkins – The Wastewater Management Plan is a guide what's to come ahead with the collection system; GIS mapping and inventory. It's the start of the plan.

Ms. Sturtevant motioned to approve \$75,000 to Fay, Spofford & Thorndike for a Wastewater Management Plan. Mr. Hobson seconded. Vote unanimous.

3. Taber & South Street Pumping Station

Mr. Jenkins – The scope from Town Meeting involved taking off some items which effected modification of the drawings. This is for bidding and construction phase services.

Ms. Sturtevant motioned to approve \$70,000 to Fay, Spofford & Thorndike for bidding and construction phase services for the Taber and South Street Pumping Station. Mr. Hobson seconded. Vote unanimous.

VIII. Executive Session

Mr. Riley motioned to adjourn the open session at 7:26 p.m. and not to reconvene the open session and enter into executive session to discuss the Digester. Ms. Sturtevant seconded. Vote unanimous.
