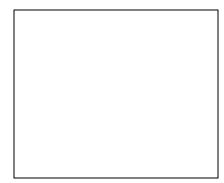
#### Present

#### A. October 1, 2012

Ms. Sturtevant motioned to approve the minutes of the October 1, 2012 meeting. Mr. Freitas seconded. Vote unanimous.

### V. Items for Action

#### A. Fairhaven Gridiron Club – Request to use Cushman Park November 21, 2102

Mr. Riley – This is for the Gridiron Club on November 21<sup>st</sup> for their bonfire.

Mr. Freitas – How did they make out last year dragging the field afterwards for nails?

Mr. Riley – It was cancelled last year because of rain.

Mr. Freitas motioned to allow the Fairhaven Gridiron Club to use Cushman Park on November 21, 2012 for their annual bonfire. Mr. Hobson seconded. Vote unanimous.

#### B. WES Construction – Payment #31

Mr. Riley – We tabled this at the last meeting because there was a conflict with the amount.

Mr. Furtado – This payment reflects the pay period August 1<sup>st</sup> thru September 30<sup>th</sup>. This number is right. There is no retainage.

Ms. Sturtevant motioned to approve WES Construction payment #31 in the amount of \$137,187.73.

Mr. Freitas seconded. Vote unanimous.

## C. Articles for Special Town Meeting

Mr. Riley – Articles are due next week. We have two in front of us. One to discuss in executive session about union negotiations that we'd like to get resolved and two; the final payment for the Anaerobic Digester negotiated with WES Construction.

Mr. Haworth - The Digester, weren't we going to transfer the money from the solar article?

Mr. Furtado – No, the money we will be using will be coming from retained earnings. The solar article will be used for the solar panels at the landfill.

Mr. Freitas motioned to approve the Salary & Wages Special Town Meeting Article for FY12 and FY13 for the Sewer Department. Ms. Sturtevant seconded. Vote unanimous.

Ms. Sturtevant motioned to sign the Anaerobic Digester Article for \$196,000.00 to take from retained earnings. Mr. Freitas seconded. Vote unanimous.

## VI. Board Members, Superintendent – Old Business / New Business

Mr. Freitas – I have nothing.

Mr. Hobson – I've already discussed this with Vinnie about the cleaning of the ditch off Jerusalem.

Mr. Furtado – That is our responsibility. It's our easement.

Mr. Hobson – There is another ditch before Potter Street that's all clogged up; Harborside.

Ms. Sturtevant – At our last meeting we had an issue with Fairhaven Excavating and Mr. DeTerra taking loam. I just want it to be known that he did not take loam. Mr. Charbonneau was talked to and it was compost. It wasn't stolen.

Mr. Haworth – The solar panels?

Mr. Furtado – That money as of last week was earmarked. After last week we were told it had to come from retained earnings. I'm assuming the solar money is earmarked for the solar panels at the landfill.

Mr. Haworth – That money was for the Treatment Plant, the West Island Treatment Plant and this building. That is sewer enterprise money.

Mr. Furtado – That was a grant.

Mr. Riley – I talked to Mr. Furtado and Mr. Fortin. We have plenty of re-reads on the water meters. It's costing us a lot of time and expense. Mr. Furtado and I talked about some sort of variance number. We could charge a normal fee if we have to go back.

- Verified with John Charbonneau that the pile that Pete DeTerra is removing compost from is indeed the pile that we offered to Fairhaven contractors. In addition, through Jeff Osuch, in exchange for some road debris/boulders which were used as fill, CC Construction (Wood School Contractor) helped out the Town by assisting in straightening out our stockpiles (using their equipment) and delivering some loam to us
