

B. Bay State Regional Contractors; Taber Street – Change Order #1 \$27,274.50

Mr. Furtado – This was tabled from the last meeting. I had a conference call with the Sewer Department Engineer, FS&T and went over line item by line item. Hopefully I can answer any questions. The person Ken Scully is willing to come in to the next meeting. The exhaust fan drawing said that the motor was going to be phase 1 but its phase 3. Because it's a phase 3 the vari-green motor Fall River Electric said it's cheaper to run and there is a rebate from Eversource. Asbestos, PCB testing during the design they didn't have a building waste survey done so this came up during the course of construction and it's just the landfill requirements that are necessary. More asbestos and more lead than they anticipated. \$4200 and \$3,100 and extra for the PCB 13,000 and change but we could be credited with some of that money back as to what comes out and how to dispose of at the landfill. Some of those numbers are a little fluffed up. They had assumed utilities \$25,000 and they came out to \$27,850 for the actual amount they need to pay Eversource. They tried to save the town money.

Mr. Wotton – How much would have a waste survey cost in the beginning?

Mr. Furtado – I don't' know.

Mr. Wotton – In my opinion I think that in a situation a survey that could be done at a minimal cost and not coming up with \$27,000 in a change order if the additional PCB disposal is over their estimated ball park will that change and go up?

Mr. Furtado – Shouldn't be another change order for the hazardous materials. Water line wasn't in the way and when they got there it was in the way.

Mr. Wotton – We should know the upfront costs.

Mr. Furtado – Typically you have to assume 10% in change orders.

Mr. Wotton - Do we see any more change orders?

Mr. Furtado - No, not for hazardous materials.

Mr. Freitas – I still can't get the jest of these little things. I'm just floored by \$2,000 for ten feet of pipe for water line relocation.

Mr. Ristuccia – That's why I want to know when they get too comfortable in their surroundings. Not that easy and the engineering people should be held accountable. Change Order for \$27,000. Do we have to pay the whole thing?

Mr. Wotton – Maybe we should move the pipe in house. Do that on our own. Anything else do on our own.

Mr. Ristuccia – Maybe what we should be doing the asbestos testing, maybe we should find somebody to get a quote. Go and look at the PCB testing.

Mr. Freitas – License plumber I don't know what triggers to give us quote. I agree with what you are saying. I couldn't see move this pipe, can we talk to them?

Mr. Ristuccia – Get other quotes.

Mr. Wotton – Do we have additional vendors typically bid this out? Are they waiting on us? Wait a week.

Mr. Freitas – Put out to bid.

Mr. Ristuccia – Check on the moving of the pipe and asbestos thru the engineering firm.

Mr. Furtado – I'll get prices.

Mr. Wotton motioned to table until we receive couple of quotes to compare. Ms. Sturtevant seconded. Vote unanimous.
