

V. Items for Action

A. GCG Associates, Inc. – Construction Observation Services for 111 Cedar Street

Mr. Furtado – We have three contracts all with GCG who is our engineering branch when it comes to utilities and highway. The first one is for sewer as-built plans for 111 Cedar Street. It's paid by the homeowner.

Mr. Wotton motioned to approve the agreement with GCG Associates for 111 Cedar Street for \$950.00. Ms. Sturtevant seconded. Vote unanimous.

B. GCG Associates, Inc. – Proposal for Jeannette Street Drainage; Chapter 90

Mr. Furtado – Remember about a couple of years ago there was poor drainage on Jeannette Street. There is a manmade pond on that street. It's been a drainage problem for a while. So many years ago the town put a catch basin in and offered the homeowner that owns half the pond to tie in. They never did. A couple years ago at the north end of the street in the winter it never thawed and you couldn't drive down the street. Last year we got away with it because of the weather. I'd like to dedicate 16,000 to have the drainage engineered and use Chapter 90.

Mr. Wotton motioned to approve using Chapter 90 for engineering for Jeannette Street drainage in the amount of \$16,905.00. Mr. Lussier seconded. Vote unanimous.

C. GCG Associates, Inc. – Proposal for Briercliffe & Sedgewick Survey; Chapter 90

Mr. Furtado – As part of the stormwater grant that the town received, not the samples to see results for outfalls but we also have a grant to do one or two depending on costs for a remediation system on Briercliffe, Calumet, Sedgewick or Smith Street, in that area. Altogether we received \$85,000 and a part of that we have to do some in house work; do some survey. The survey equipment we have here is not sophisticated enough we can't generate the computer data for GPS. Hire GCG for \$4,960.00 to do this work. They are going to do a survey and turn it over to the company we hired to put the stormwater system in for us.

Mr. Wotton motioned to approve using Chapter 90 for survey services in the amount of \$4,960.00. Mr. Lussier seconded. Vote 3-0 in favor with Ms. Sturtevant abstaining.
