- Rank 1- Parking/Bike Racks
- Rank 2-3 Safe Routes to Schools-(need to get schools to "buy in")
- Rank 1- Bicycle Education-schools/seniors-brochure/publication
- Rank 1-2- Commuting
- Rank 1- Mountain Bike Trails- (Greg will map out trail on New Boston Road and get help with clearing)-? CPC funds for parking lot-CPC money can be used because the land was purchased with CPC funds
- Rank 1- Sponsors/friends- outreach-bike-a-thon
- Rank 1- Data Collection-(can help with funding)
- Rank 1- Survey/census-(Ken will contact Marion to look at their survey, Julianne will contact Adam at SRPEDD regarding surveys, Bill will talk with Eileen regarding adding survey to town census mailing)
- Publicity-Nancy will contact media with Bike Path Committee announcements as needed-Neighborhood News, Advocate, Standard Times
- Mention of the Neighborhood News article on Bike Path Safety

- Friends Group- Bill will check with Falmouth regarding whether Bike Path Committee members can also be members of Friends Group
- Regional Bike Path Committee Report-voted for Southcoast Bikeway to be spur of East Coast Bikeway – approximately 25% completed-they are supportive of effort for Southcoast Bikeway to extend from Providence to Provincetown-goal is for Southcoast Bikeway to be a commuter bike path-discussed adding Fairhaven Bike Path info as an insert to Southcoast Bikeway brochure
- Other Business:
 - Clean up Day- Bob and a few other citizens rode the path, cleaning up trash where noted-he reported that overall, path was pretty clean- Kathy mentioned that BPW helps to maintain path and cleanliness
 - ✓ Matt questioned if committee should be involved with DCR/Fort Phoenix-Bill reported that striping/signage down Laurel St is plan to connect to Fort Phoenix
 - ✓ Matt brought up for discussion changing name of Committee to Fairhaven Bike Ways Committee-decision to continue with current name
 - ✓ Bill discussed Transportation Improvement Plan-Town's can apply for money for bike racks
 - ✓ Kathy reported that she needs to be appointed by BPW to sit on Bike Path Committee as a representative of that Board
 - ✓ Kathy reported that she took pictures of bike path damage to BPW and graffiti was removed and damage repaired where noted-Greg provided another picture of a damaged fence that Kathy will bring back to BPW for attention
 - ✓ Julianne shared upcoming event "Walk the Phoenix Rail Trail for Wild Edibles with Russ Cohen"- will take place on Monday, June 4th from 6-8 pm-group –sponsored by the Southcoast Outdoor Network
 - ✓ Julianne and Bob suggested that we publicize on website upcoming events such as: June 16th- Fall River to Dartmouth ride, June 24th Mattapoisett ride, July 14th- Cushman Park event "Bicentennial Family Fun Day"-"Bike Around Town"
