Per suggestion of Jeff O'Such, a quote will be requested from Morency Carpet as well. The carpet to be used will be a commercial grade of 2'x2' square carpet tiles that are easily replaceable if necessary in the future. Two quotes were requested from each company-one for the entrance area, lobby and hallways and a second quote for all offices.

### **OTHER**

The Supportive Social Program has grown in number of participants and within the 5 years, it is anticipated that the number of seniors attending the senior center for events and activities will increase to the point of outgrowing the present space. to design additional space (Kelleher, Booth, Vorhis) and discuss a possible feasibility study for an addition to the senior center.
