# **The Directors Report**

The bumper was temporarily attached by the garage a couple of weeks ago. Quote from Quality Van to replace it is \$504.14 which will come from vehicle maintenance line.
- 2. Glass panel in front entry was shattered by a stone during weed whacking. Cost to replace it is \$635.00 which will come from building repair line. The insurance company stated we have a \$10,000.00 deductable for any damages to the building.
- 3. The LGBT Aging Project from Boston will be conducting a focus group at the Fairhaven Center on Monday November 2, 2015 from 11am-1pm. The speaker will conduct a presentation on housing issues related to the aging LGBT population.
