October 27, 2015 Meeting Minutes

Meeting was called to order at 10:05 a.m.

MINUTES

Ms. Graves motioned to accept the minutes of the October 15, 2015 meeting. Mr. Furtado seconded. Vote was unanimous. (5-0).

POLICE REQUESTS

At 10:05 a.m., Police Chief Michael Myers presented the Police Department requests for FY17. There are:

- 1. Two Police cars (annual replacement) \$78,345
- 2. 2004 Safe Boat \$30,000 (New Bedford has a boat to purchase), if Port Security Grant approves the outfitting of the boat. This boat would replace two existing boats 1995 Boston Whaler and 1997 SeaHawk
- 3. Discussion on New Public Safety Building \$30,000 feasibility study in FY17
- 4. Radio system \$100,000 to replace outdated system with service issues, used with Acushnet and Mattapoisett. The chiefs of the three communities are working together on this
- 5. Police communication equipment \$150,000 for FY18 /FY19. Either replace or it would be included in a new building

NATURAL RESOURCES REQUESTS

At 10:33 a.m., the Board met with Harbormaster Tim Cox to hear the capital needs of the Natural Resources department.

- 1. FY17 New Truck for \$40,000 the department has two trucks: a 2003 purchased secondhand truck with brake and transmission issues, and a 2010 truck for towing boats the truck is too small to tow the large boats. Mr. Cox wants to replace the 2003 truck an F150 is too small
- 2. FY18 20-22' work boat for \$45,000.

Current boats in the fleet:

- a. 25' Boston Whaler (1990s) 6 year old motors
- b. 27' Whaler \$200,000 boat purchased new in 2012
- c. 21' Whaler shallow draft can go down rivers and go under bridges 150 HP purchased in 2007
- d. Carolina Skiff transplants quahogs but has issues (requesting replacement in FY18)
- e. Pumpout boat only for pumpouts

- f. Two 8' inflatables 4 HP
- 3. FY19 Aluminum Barge (\$50,000) New item to seed quahogs and oysters for propagation. NB Voke may be able to build this. Could combine the purchase with the Carolina skiff to be more useful
- 4. FY20 Truck (\$40,000) to replace the 2010 F150

SEWER DEPARTMENT REQUESTS

At 11:00 a.m., Linda Schick presented the requests from the Sewer Department.

The Sewer Department has changed requests. See the revisions in Attachment A. \$7.61 million is to be borrowed in FY17. A sewer rate increase ($$0.55/100 \text{ cf} \pm$) will be required to fund borrowing. Additional rate increases in each year: FY18 through FY21.

WATER DEPARTMENT REQUESTS

At 11:25 a.m., Vincent Furtado presented the requests from the Water Department. See the revised sheet in Attachment B. The BPW will need to raise water rates in FY17-FY19. There are no anticipated projects in FY17. A borrowing is expected in FY18 for \$2 million.

HIGHWAY DEPARTMENT REQUESTS

At 11:30 a.m, Vincent Furtado presented the requests from the Highway Department. See Attachment C.

TOWN HALL REQUESTS

At 11:45 a.m., Jeffrey Osuch presented the requests on behalf of the Town Hall. Excluding the Town Administrator vehicle, the rest of FY17-FY20 requests would be submitted to the CPC for historical building repairs.
