

Minutes of the Meeting for < APR 12<sup>th</sup>, 2012> at the BPW Building, Arsene St., Fairhaven, MA

Members in attendance: Chairman- John Roderiques, Pat Elliott, Kim Hyland, Therese Szala, Kathi Carter, Scott Fernandes, Ron Quintin, Lisa Plante and Ted Silva. Not present- Sid Martin, Jennifer Bishop. This meeting was televised.

Meeting called to order by Chairman John Roderiques at 7:03 P.M. and announced that the proceeding was being video/audio taped by government access.

Minutes from prior meeting of 4/5/12 were reviewed. Motion to accept by Kim/ Ron unanimous (8-0- Scott in later)

Vin Furtado, Supt BPW in to discuss issues-

Art. 7 Special TM \$3000000 for digester. Explanation included a new engineer on site. Given change orders close to \$300000. Chair asked if taking steps to protect town. Ans YES- hired independent review anticipate getting money back. Specifics include electrical, ledge and other issues. Chairman reminded all that initial cost is a loan now but will become a grant if project is completed to satisfaction of the state.

Motion for \$300000 from sewer retained earnings by Terry/Ron unan 8-0

Mr. Furtado noted highway may sign contract on Tuesday.

Chairman explained that Art. 1 sec 4 e3 Equipment is the street sweeper removed from annual and put in special.

Chair noted reserve fund must be used to balance budget. Request for \$25000 for health insurance currently is spec TM

Art 1 sec 6. Chair suggested doing reserve fund transfer instead. Motion for reserve fund transfer for \$25000 for group insurance - Kim/Terry unanimous

Chairman noted may need additional \$12200 for town clerk budget partially because of special election, special town meeting and Mass statue updates.

Chair advised House Ways & Means released budget and more money should be coming. Roughly \$200000 proposed. Chairman was clear not to expect that amount. Also that state often takes funds from other areas. Chairman estimated town could receive additional \$125,000 to 175,000 and suggested possible uses for unemployment insurance, stabilization fund and street lights.

Remaining Special Town Meeting Articles-

Chair noted that Art.1 sec 5 of Special TM requested funds for Veterans services. Suggested that some of these requests should come from the reserve fund.

Chair suggested motion for reserve fund transfer of \$20,000 to partially cover veteran's request of \$28000 in Art 1 sec 5d- Vet benefits. Motion for transfer Terry/Kim vote unanimous with Ron abstaining. Chair suggested motion for \$20,000 as reserve fund transfer to partially cover \$31,000 request for Art.1 sec 5b- purchase of services. Motion for reserve transfer of 20000 by Terry/Kim vote unanimous 7-0 Ron abstained.

Vote then taken on Art.1 sec 5 b & d to fund remaining amounts.
