Minutes of the meeting for **February 13, 2014**>at the BPW Administration Building, Arsene St., Fairhaven, MA

Meeting was covered by government access television. Member of the press was not present.

Chairman called the meeting to order at 7:02 PM. Announced that the meeting was being recorded by government access TV. Chairman has to be notified if anyone else present is recording the meeting by video or audio.

Motion made by Scott to accept the minutes from February 6, 2014. Seconded by John M.

• Mr. Osuch passed out updated draft of the May Town Meeting warrant, updated copy of the Article 4 spreadsheet, and updated spreadsheet of the Articles.

7:07 PM. Meeting with Warren Rensehausen-Recreation Director, to discuss his budget.

• Chairman asks Mr. Rensehausen to give the committee a brief update of what is going on at the Rec Center.

- Mr. Rensehausen states that they have restarted the afterschool program at the Wood and East Fairhaven Elementary Schools.
 - They have approximately 44 participants each day between the 2 schools.
 - The program so far has brought in \$35,515 with expenses amounting to \$18,000.
- Mr. Rensehausen states they are doing occasional trips to the casinos as well as trying to plan a trip to Maine in the future.
- Mr. Rensehausen explains that his budget with a 1% increase would include the purchase of a storage shed.
- The budget with a 2% increase would include the purchase of the shed as well as an inflatable water slide for use during the summer program.
 - Currently, they rent a slide every Friday during the summer program. That slide rents for \$ 125 each week.
 - If they do not get the shed they would not get the slide, because there would be no place to store it.
- The Chairman and Mr. Osuch discuss the Program Fees & Membership Fees.
- This year to date, the Rec Center has taken in \$ 129,906 in revenue. Mr. Rensehausen expects to hit \$ 200,000 for the entire year.
- Terry questions the charge for Digital Document Solutions.
 - Mr. Rensehausen explains this is for software the center uses.
- Terry also questions the charge for GM Refrigeration.
 - Mr. Rensehausen explains that service was required on the roof top HVAC units.
- Mr. Osuch asks Mr. Rensehausen what his plans are for future equipment replacement. Mr. Rensehausen states that 2 pieces of equipment were purchased the previous year and the existing plan is to try to replace 2 units every other year. That would amount to an expense of approximately \$ 10,000 next year.
- Pat asks what the size of the shed would be, how long the slide would last, and whether the salary line includes the 1/2%, and 1% increases for the year.
 - Mr. Rensehausen states the shed would by 8' by 10', similar to what the COA is using. The slide is expected to last at least 5 to 7 years.
 - The Salary line is correct. Some employees have left and the replacements are at a lower step.
- Mr. Rensehausen states that starting April 1st. the Rec Center will be offering online registration and accepting credit cards.

Having answered the committee's questions, Mr. Rensehausen leaves the meeting at 7:35 PM.

February 20th the Selectmen will be having budget meetings between 5:00 PM. and 7:00 PM.

The Finance Committee will still have their meeting, but will not have any appointments.

 - Since switching to the LED lighting the cost has gone done significantly.
 - Next year this line will be less because the Town will not be purchasing any new lights.
 - Chairman asks Mr. Osuch if there is any money built in the budget to eventually replace the lights as needed.
 - Mr. Osuch states the lights have a life expectancy of 17 years.
 - Mr. Osuch brings it to the committee's attention that this line item also covers 2 sets
 of traffic lights, and the warning lights at the school crossings.
 - Scott motions for \$ 90,000. Seconded by Terry. Vote: Unanimous

 - Scott motions to recommend \$ 6,500 for #12 Town Hall b. Purchase of Services
 Telephone system. Seconded by Terry. Vote: Unanimous

- Look at streets and street light Article.
- Look at the smaller budgets to see if there are any questions.
- Chairman will contact Police, Fire, and BPW for appointments to come in.
