Minutes of the meeting for **October 30, 2014** at the BPW Administration Building, 5 Arsene St., Fairhaven, MA.

Chairman called the meeting to order at 7:05 P.M. Announced that the meeting was being recorded by government access TV. Chairman has to be notified if anyone else present is recording the meeting by video or audio.

Due to absence of Committee Member and recording secretary Robert Furtado, no action taken on prior meeting minutes.

Draft of special town meeting warrant is distributed by Mr. Osuch. General discussion ensues.

Based on discussion committee decided to vote on articles as noted below. Unless otherwise noted, all motions were made by Scott Fernades and seconded by Theresa Szala and all votes were unanimous, and were recommended in the amounts noted. Funding source for all articles unless otherwise noted is to be from surplus revenue.

Article 1 – Town Charges: General Government – Audit Expense \$4,000; Police Department, b. purchase of services \$11,700; Shellfish Inspection, b. purchase of services \$2,000.

Article 2 – Funding of Labor contracts – FY 14 and FY 15: A. Dispatchers Union, A. Salaries and wages \$2,761; and B. \$2,990.

Article 9 - Stabilzation - Sewer Betterment

Note: all amounts to be taken from the dedicated accounts noted in the warrant and to be transferred to the accounts noted in the warrant

- a. Sconticut Neck Sewer \$170,761.68
- b. West Island Sewer \$33,288
- c. Nancy Street Sewer \$8,723.98
- d. Boulder Park Sewer \$966.00

Article 10 – Sconticut Neck Sewer Debt – transfer from dedicated sewer betterment stabilization fund to be used to pay down the debt in amount of \$1,850,000.

Article 11 – Nancy Street Sewer Debt – transfer from dedicated sewer betterment stabilization fund to be used to pay down the debt in amount of \$195,000.

Article 12 – Community Preservation Committee FY14 Transfer from unrestricted funds account to Housing reserve in the amount of \$10,000 recommended adoption.

Discussion relative to how to handle remaining articles occurred.

Based on nature of articles and perceived need to await further hearings/action by selectmen for the Mill road property purchase under to be submitted and need for clarification and/or documentation on other articles, and taking into account time frame needed for publication of warrant with recommendations, committee consensus was no need to meet until November 20<sup>th</sup>. As such November 6<sup>th</sup> schedule meeting to be postponed until that date.
