- Chairman presents a Request for Deficit Spending, in the amount of \$ 15,000, for the Highway Department- Snow & Ice.
 - The line item is currently showing a deficit of \$3,217.42
 - Scott motions to authorize Deficit Spending in the amount of \$15,000. Seconded by John M.. Vote: Unanimous
- Chairman states the Fire Chief will be in next week.
 March 5th the Selectmen will be back

Chairman is trying to schedule Police Dept. & BPW after that. Schools should be in the end of March

- Chairman advises members to look at all the roads that are petitioned.
 - Also, look at the 2 street lights that are petitioned.
 - The policy has been lights on every other pole. If there are none existing, look at where it would be best placed.
- Chairman brings up Historical Commission Articles. Asks Mr. Osuch if he has seen any backup for the increases over last year.
 - Mr. Osuch states no.
