- 2. The Special Needs Early Childhood Revolving Account may be expended for all school related costs for the public school's Special Needs Early Childhood programs including, but not limited to, transportation, the purchase of equipment and supplies and the hiring of full-time and/or part-time personnel.
- 3. All tuition, receipts, and enrollment fees charged for participation in the Special Needs Early Childhood Program shall be credited to the Special Needs Early Childhood Revolving Account.
- 4. The School Committee is authorized to expend from the fund. Voted 6-0 unanimously

Motion made by Mr. Roderick and seconded by Mrs. Powers authorize a Use of School Property Revolving Account under the provisions of Massachusetts General Law Chapter 71 Section 71E. Voted 6-0 unanimously

Motion made by Mr. Monroe and seconded by Mrs. Powers to vote a certified budget figure for FY 2016 of \$18,737,194. Voted 6-0 unanimously

Motion made by Mr. Monroe and seconded by Mr. Veitch to adjourn the regular School Committee meeting, go into executive session to discuss contractual issues and return into regular session. Roll call: Veitch-yes, McKenna-yes, Powers-yes, Monroe-yes, Roderick-yes, Kuechler-yes Voted 6-0 unanimously
