Item 6 Order to authorize the Town Manager to execute an easement from the Town to E. Marie Manganello, who owns property.

176 Foreside Road, such easement to allow the installation of underground utilities crossing Town owned conservation land.

Mr. Horace Horton, representative for E. Marie Manganello discussed the possible options for utility installation and an easement from the Town.

Councilor Chase moved to authorize Town Manager Nathan Poore to authorize and negotiate an easement based on Town attorney Bill Plouffe's advice and Mr. Horton's two recommendations, subject to the Town's approval, on where the path of the utilities should be as well as compensation of all out of pocket costs to the Town. Councilor Libby seconded. Motion carried 6-0.

Item 7 Staff will present an outline for a proposed economic development resource website as well as a draft available commercial property database for Falmouth.

Long Range Planning Director Theo Holtwijk gave a presentation and answered questions concerning a proposed web-based economic development resource package and available commercial property database. Theo Holtwijk will work with Councilor Armitage and contact FEADC and the Falmouth - Cumberland Chamber of Commerce to obtain feedback and more information on the project. The findings will be presented at a future Council meeting.
