Q5: Please select the preferred level of service for METRO Route #7 bus service provided by the Town. Background: METRO Bus Route #7 runs from downtown Portland to various Falmouth locations, including Wal-Mart, Shops at Falmouth Village, Shaw's, Johnson Road, Town Landing Market, OceanView, and Falmouth-by-the-Sea. The bus runs once per hour Monday through Saturday, from 6:30 AM to 7:25 PM. One way fares cost \$1.25; seniors pay \$0.60. Free rides are available through participating merchants.

	Please add any comments you have about this service
1	1) I'd like to use the Metro within Falmouth, but the schedule isn't conducive to this. I'm thrilled that the option exists, but would like some midday routes on the Foreside instead of only very early and end of day schedules. 2) I don't understand why the Metro hasn't been mentionned as a possible aid in alleviating the supposed Town Landing parking problem. It runs from the Shaw's parking lot to Town Landing 3 times on Saturday morning and again in the late afternoon, exactly when boaters would need it. Why talk about a town run shuttle when there is an obvious solution the town already has a stake in.
2	Although we do not take advantage of this service, I think it is a great service for people who do need this service.
3	Am torn. Public transportation is the way to go. To reduce it reduces opportunities for people from other communities to come to work here, as well as opportunities for residents to get to the shopping area, library, and Portland. Possibly a smaller vehicle* might be used as more people catch on (*if indeed it would save any money).
4	An increase in Metro service would further benefit the town.

5A	MAINTAIN CURRENT METRO BUS SERVICE (NO CHANGE IN FUNDING)
5	As a resident of the western side of town, I am fully aware that all decisions made on this topic (as most others) discriminate against the West in favor of the East. Take a good look at the route of this metro-bus. Funny how it stays East, isn't it? Too bad commercial tax rate is not less on the Western side (unless of course, one is a "developer" and is given TIF to add to the small business burden).
5	As we become more green, which I believe to be inevitable (more and more people at my firm are giving up driving), public transportation will be more critical.
6	Do not use, but (who knows) may in the near future; do not use because of where we live but, nonetheless, we support mass transportation and the transport options this service offers our community.
7	do we now the current ridership? I find it inexcusable that you would offer option 3 without presenting the ridership.
8	Don't eliminate altogether. This is helping putting Falmouth on the map, but it needs more strategy context to make Route 1 a stronger destination.
9	Excellent. Where I do not drive, it allows me to make a lot of my appointments by myself without bothering someone else.
10	Great service - like that the sidewalks are cleared to make it easy to use the bus
11	Hugely important for folks who do not drive and are dependent on public transportation.
12	I do not use the service. I believe it is a necessary service and I don't see a benefit to users if it is reduced to Route 1 only. Is reducing # of runs daily an option - or increasing fare(s)?
13	I don't currently use this service, but I think it is very important to many seniors, and will likely be increasingly important as the price of gas inevitably rises.
14	I don't know how many use this service, but it certainly must be an essential service to those who don't/can't drive. It's easy to vote to cut a service one doesn't use, but the town management must know its importance to some who depend on it.
15	I feel this service is essential for seniors
16	I have not ridden it, but it was very useful for my older brother(Roger Snow) when he could no longer drive.
17	I live along Route 1 and have seen ridership on the bus grow over the years. It's a great way to reduce traffic and move people relatively cheaply into and around Falmouth.
18	I might favor reduction or elimination if utilization is very low.

19	I returned here to live from Pennsylvania in 2004. I was raised at Skillins Corner. I would hate to think that the senior citizensor or any other persons living on Route 88 would ever be denied Metro Service. Foreside Harbor and Falmouth By the Sea are important to the senior citizen as well as OceanView residents benefit from the METRO. Persons working at these three sites as caregivers often need to use public transportation to get to work. The businesses along Route 1 benefit from persons using the bus to go to shop there. Please consider these factors in your decision. I support all current Metro service. Do not eliminate.
20	I think this a great service to Falmouthgreen, inexpensive and an added value for students, people with only one car and seniors. If development of route One continues i see expansion up rt one to serve Tyler and asociated businesses. Great asset.
21	I use this service several times a week, and buses are frequently near-full during the rush hours when I ride. This is an important economic development tool - espiecially for the "creative economy" workers of my generation, who are uninterested in spending hours in a car every day. If anything, Falmouth should invest more in this service and run the buses every 30 or 20 minutes during morning and evening rush hours. 1	1) What does an analysis of ridership indicate? Oceanview and Falmouth By the Sea should provide for resident transportation for now.
2	A much smaller bus could probably serve this route as well, and more efficiently/cheaply, than the current vehicles being used. More service during the 7-9 am and 4-6 pm ranged would probably draw more commuters; mid-day service seems less useful to many. Evening service (esp on Fri & Sat) might be used by many who'd like to have dinner/drinks/concert/etc. in Portland not currently an option.
3	Are seniors in Falmouth really that poor? They can probably afford the full \$1.25
4	can revisit this once economy improves
5	can you use a smaller bus for outlying areas away from Route 1?
6	Change the route to include Falmouth Schools and Univ. of Southern Maine so the service benefits the younger generation of Falmouth residents as well as the small number of current users of the service. Otherwise, cost of the service is not justifiable.
7	Good idea but I must still drive a car to catch the bus so I drive to my destination.
8	How many people use this service?
9	How many residents use the service per week? Why run such large buses for so few riders? Go to a van instead.
10	I like the idea of public transportation for our community, but it is disturbing to see empty buses time after time along Rte. 88. It gives me the impression that the service is not used as intended in this community. If that's so, do we know why? Lack of need? Attitude of residents toward public transportation?
12	I never see more than 2-3 people on this bus.
13	I see the bus making its rounds quite frequently. Very seldom do I see more than 3-4 riders, and often none at all. I would make it more of a user oriented service with the riders paying more of the cost.
14	I see the Metro go by my house in the morning and evening with little or no ridership.
15	I would like to see the Metro service Rt. 1 from Portland to Freeport.
16	If cutting the Metro to just serve rt. 1 how much of the ridership would we still serve?
17	if it ran on Sunday I'd use it that day.
18	If this service is not breaking even in a short period of time it should be done away with. 5 years tops.
19	I'm close to saying eliminate it altogether, based on what I've observed for ridership levels. But decreasing service to just Route 1 would be a first step.
20	It depends on the level of usuage.
21	It would be easier to answer this question if I knew how much the current bus service was being used. Are the buses 1/2 empty frequently, etc?
22	Often this bus is never on time. I find it difficult to rely on but its a nice option in a pinch and it gets people to WalMart, etc. to shop.
23	Or consider a van service which might be less expensive than an large and unoccupied bus.

3	At a minimum reduce service to once every 3-4 hours. However, no intelligent decision can be made without an actual usage survey. Until that information is available, cancel the service.	
4	Bus is always empty and causes an environmental problem - smoky exhaust.	
5	buses always look empty/ underutilized. Publish actual # riders and cost /trip and citizens will see large subsidies	
6	Cost to much for amount of riders.	
7	Do a cost benefit analysis on fares/expenses. IF we are not within a range of breakeven, then this service should be reduced. Do not subsidize further.

13	Have never used this service and have no use for it. Not sure how much other citizens utilize this service.
14	How many Falmouth residents actually use the system and what is that percentage of total?
15	I am unaware of how many people use the metro in Falmouth. If the numbers are small - eliminate the service. If the numbers are large, consider reducing the number of times it runs (every other hour instead of every hour, etc). Also consider increasing the cost per rider.
16	I believe this service mainly benefits non-residents coming to and from Falmouth, especially those going to WalMart. I see this bus often and it it usually carrying fewer than 10 passengers, many times just one or two.
17	I believe we need to determine what specific needs the bus is serving, and whether there are alternative and less costly ways to meet those needs.
18	I can't see spending all of this money when I don't see very many people using this service. (Oceanview and Falmouth-by-the-Sea has their own transportation)
19	I do not feel there is a need to provide public transportation being a rural community. The elderly have other means of transportation and some of it subsidized. Those are the only people we should feel obligated to provide transportation to in this time of budget issues.
20	I don't believe that the Falmouth Citizens use supports the expense
21	I don't know that Route One is.
22	I don't use the service and never expect to. Why should we subsidize WalMart to get it's poorly paid employees from Portland to Falmouth?
23	I have never met anyone who took the bus. No stops are within walking distance of me. I'd have to drive to a stop, and there is nowhere to park. I love the idea of the bus, but I work in Westbrook, so for me, it's not practical.
24	I have watched this ridership since its inception at all hours of the day and the ridership is very limited.
25	I hesitate with this choice and wonder how many residents access this service.
26	I observe the bus coming from and going to its destinations, and there may be one or two people at most on the bus, and mostly it appears empty. Taxi cabs, family and friends with automobiles are a much more cost effective delivery of transportation service for those that need it.
27	I rarely see any Falmouth residents riding the bus especially on Route 88. I'd rather see a "van" or bus service that has a direct route from the Maine Mall to Freeport with Route 1 stops in Falmouth and Yarmouth. This would cater to a broader range of citizens (teens, seniors, tourists etc.) and be much more cost effective. Who wants to do the "transfer" in Portland on Congress street to get to the Mall or walk down to the Old Port. YUK!!

While the cost of disposing of trash is covered by the sale of yellow bags, weekly curbside trash collection is paid for through property taxes. Recyclables, such as paper, plastic, metal and glass, are collected bi-weekly at curbside. Property taxes pay for collection and there is no charge for disposal. Property taxes also pay to haul recyclables in dropoff containers, known as "silver bullets," from three Falmouth locations.

29	I have a couple of ideas. What if the silver bullets outside the transfer station were eliminated? If all Falmouth residents have curb-side recycling and can take their trash and recyclables to the transfer station should they miss pick-up, aren't the Bucknam Rd. and Hannaford silver bullets excessive? Businesses are responsible for their own waste disposal and recyclables, aren't they? They don't need the silver bullets at Bucknam and Hannaford's either. I am also told the silver bullets may attract non-Falmouth recyclables. On the other hand, maybe there are no significant savings in getting rid of some of the silver bullets. Maybe that's why this idea was not on the list of options? Perhaps trash pick-up could be bi-weekly along with recycling. Now we have all the dirt and leaves on the street after the fact. This happens every year. Also checked your records and see how many times the town has had to fix the sign near Andrews Ave & Greenway Drive because of a car or truck accident. I'm sure the plow drivers would be just happy to see them go. I know I would.

I find this curious (and expensive?) as the roads look like rural highways (the 55 mph kind) in a town which prizes its rural/town character. It's my opinion that some bumps and imperfections are desirable; they slow folks down a bit, make them attend to their surroundings. What's with the double yellow lines on our town roads? Maybe it's a state standard, but it makes our roads look more like highways and I bet the paint costs a bit (a little bit, I'm sure). They don't even discourage passing!
271	The OceanView Retirement Community is the largest taxpayer in Falmouth and the complex and the town have always enjoyed a good relationship. In our publicity we are listed not simply as "OceanView" but as "OceanView at Falmouth" as we demonstrated recently when announced as a sponsor at the fifteen performances of the PSO's annual Magic of Christmas show. It follows that the continued service of Metro is a must for the Town of Falmouth.
