Green Ribbon Commission Report  
Energy and Climate Protection Plan - 2010

- WHEREAS,** the Town Council appointed an ad hoc commission known as the Green Ribbon Commission (GRC); and
- WHEREAS,** the GRC was tasked to make climate protection recommendations to the Town Council and Town Manager on how the Falmouth Community can meet its pledge under the U. S. Mayors Climate Protection Agreement; and
- WHEREAS,** The Commission’s work has followed ICLEI Local Governments for Sustainability (“ICLEI”) “Cities for Climate Protection Campaign Five Milestone Process”; and
- WHEREAS,** the GRC has completed its task to submit a comprehensive Energy and Climate Protection Plan to the Town Council; and
- WHEREAS,** the GRC offered several presentations to the Town Council during the past year culminating in one final presentation at the regularly scheduled Town Council meeting on April 26, 2010.
