A short survey was posted on Town's website and has exceeded 370 responses.

- About half of the web respondents provided an e-mail address in order to receive periodic project updates.
- Survey return boxes have also been set up in Town Hall and at Library for paper returns.
- A short video is in process of being produced for cable TV and Town's website to further promote the project and survey.
- A statistically-valid survey is being considered, which would allow comparison to prior statistical surveys by the Town.

Some Early Observations

- The initial survey indicates an engaged community with many residents quite positive regarding Falmouth and interested in the Comprehensive Plan process.
- Home-based businesses, although hard to quantify, appear to be growing in importance. They may have important positive impacts on commuting and the town's "village" character.
- There is critical need to develop a West Falmouth Sewer Master Plan.
- Residents need to be engaged through digital methods, but also in traditional ways.
- A statistically-valid survey is important to gain reliable and replicable resident perspectives.

Schedule

- LPAC+ has as a goal to complete the plan in 12 months (26 meetings) and deliver a recommended plan to the Council in 2011.
- The initial draft schedule (subject to revision) is:
 - Data collection of first round of categories (2) June 2010
 - Subcommittee reports regarding data collection (1) July 2010
 - Discussion of first round categories (1) July 2010
 - Data collection of second round (remaining) categories, and discussion with 2000 Plan members (2) August 2010
 - Subcommittee reports regarding second round categories (1) September 2010
 - Discussion of second round categories (1) September 2010
 - LPAC visioning (2) October 2010
 - Public visioning (3) November-December 2010
 - Discussion of public visioning (2) December 2010-January 2011
 - Revision of LPAC vision (1) January 2011
 - Plan writing (2) February 2011
 - Public comment on Plan (1) March 2011
 - Public comment discussion (1) March 2011
 - Final plan writing (4) March-April-May 2011
 - Miscellaneous issues (2)

- Plan statistically-valid survey
- Prepare a draft LPAC vision
