## Re: "Quiet Zone" along Pan American Railways Line

On October 24, 3011 staff reviewed possible proposed Quiet Zone (QZ) designs at Falmouth's four crossings with the Council. It appears that a Quiet Zone can be obtained for an estimated construction cost of up to \$127,000 and that a formal approval process with Federal Railroad Administration (FRA) is not required. The Council decided to hold a Public Hearing on this matter on November 28, 2011.

### **CROSSING DESIGNS**

- Staff explored "channelization" safety improvements at all four crossings, consisting of a 2.5 feet wide traversable median with 45 degree granite curb. The delineator package would then be mounted on the median. This work mandates a slight road widening. Staff believes this is a design that will hold up better than other designs in adverse conditions and during winter maintenance (snowplowing) operations.
- 2. The FRA offered an informal opinion that such channelization improvements qualify this corridor for a Quiet Zone. An approval process will not be required, but a notification process will be required.
- 3. Improvements at the Field and Woodville road crossings would be mandatory for a Falmouth Quiet Zone involving all four (public) crossings. Improvements at the Blackstrap and Falmouth road crossings would provide additional safety and be at the discretion of the Town.
- 4. Staff prepared a sketch that shows the Falmouth Road crossing with possible car and truck movements that could potentially bypass a closed two-gate situation (see below).
- 5. Staff also explored with the FRA the alternative safety measure suggested by Councilor Chase involving extending a crossing gate over both lanes of traffic, not just one lane of traffic. This would form a vehicular traffic block across the entire two-lane road on both sides of the crossing. The November 8, 2011 response from Randall Dickinson of the FRA regarding this suggestion was as follows:

"As I'm guessing you're already aware, a gate extending across both lanes of traffic, such as you're suggesting, would not qualify as an SSM [Supplementary Safety Measures], as defined in the Reg.[Regulations]. It is, however, an arrangement that you could certainly propose as an ASM [Alternative Safety


Measure] ..., as defined. Doing so, of course, would negate the possibility of any automatic approval that would be enjoyed by using all SSM's.

Use of ASM's triggers the application and approval process. Although my knowledge of any such arrangements elsewhere in the country is very sketchy, I do believe there have been certain isolated cases where they may have been approved, due to unusual and/or mitigating circumstances. I do know that Washington has expressed some heartburn with respect to this concept – due mostly to the gate timing issue. However, that having been said, I feel safe in stating that such an application would surly receive serious consideration - no guarantees of approval, of course."


