#### Town Council Meeting Minutes May 27, 2008

#### **Roll Call Council Attendance**

Present and answering roll call: Councilors Wrobleski, Goggin, Rodden, Armitage, Breen, Payne & Libby.

#### Public Forum

**John Barrows** spoke regarding a donated map by the Galeyrie in council chambers and explained the background as follows: "An archival reproduction of "The New Railroad, Township and Topographical Map of Maine" published in 1855 by J.B. Mansfield, Bangor has been donated to the town of Falmouth by Galeyrie Custom Framers and Fine Art of Falmouth. John and Sally Barrows of Galeyrie will gift the framed map for display in the Town Hall, and the town will donate one hundred fifty dollars to the Falmouth Historical Society, inaugurating a program to benefit the Society through the sale of historic maps.

The pre-civil war map shows inset details of the old Custom House (before the Great Fire), the Marine Hospital at Westbrook, the Theological Seminary in Bangor, Berwick Academy and the State House in Augusta. The map is unique in that it was published in Maine at a time when most state maps were produced in New York or Boston. It is a fine example of what is considered a "schoolhouse" map that hung in every schoolroom in the mid to lat 19<sup>th</sup> Century.

The Falmouth Historical Society has maps relevant to local interest in their archives that Galeyrie will scan and offer for sale. A portion of the sale of each framed map will be donated to the Historical Society in an on-going program to benefit the Society.

On June 14<sup>th</sup> an opening of the Falmouth Historical Society is planned for 11 AM.

**John Winslow** spoke as a taxpayer and asked questions relative to harbormaster services, animal control officer, etc & inquired if the council authorized a signing of an agreement between parties.

**Chair Breen** responded that as much as we try to be responsible and diligent in our duties we also have a Charter to follow.

**Nathan Poore**, town manager explained that this item has been brought to the Harbor Committee and this is a mutual aid agreement with the federal government and is a fairly simple matter.

Setback violation – 21 Hedgerow Drive
Closing: Estate of Caswell to Dawn M. Keller

Dear Members of the Falmouth Town Council:

Approximately 45 days before my pending closing of 21 Hedgerow Drive, a mortgage inspection plot plan, ordered by the title company, revealed a setback violation of approximately 2 feet at the rear left corner of this property.

This problem was described to you by the seller's attorney, Terry Snow, at your workshop on May 19. At that meeting, the council tabled the seller's variance request, removed it from its May 27<sup>th</sup> agenda, as the council contemplates a policy to address such violations.

In late June, I am expected to close on this property. My present home in Falmouth is under contract; and my family and I have to vacate before June 25. As a single parent with 3 children, I need to have a home for all of us, and may have to close on 21 Hedgerow, and inherit this problem.

20 years ago, a previous owner was granted a variance by the town of Falmouth to construct a small addition to the back of 21 Hedgerow Drive. Without benefit of a survey to guide the construction, the new addition was built and unknowingly encroached on an approved variance by approximately 2 feet at the back corner of the house. This was an inadvertent mistake. The subsequent buyer of the property, Mr. and Mrs. Caswell, did not conduct a survey or mortgage inspection plot plan at the time of their purchase. Therefore, they were unaware of the violation. The personal representative of their estate was made aware of this violation in the last few weeks.

Tonight I ask the town council to consider a consent agreement to address this mistake. I ask you to do so, prior to the council establishing an overall policy with regard to violations that the council may have to consider in the future.

#### Item 2 Report from Council Committees and liaisons regarding updates on assignments.

**Councilor Rodden** commented on a survey for METRO. The METRO bus has been running for 4 years and "we want to find out who is riding the bus and what would it take to get more people on the bus. There are 3 surveys: business, school and residential. This is being done in-house with the cost of under \$1.000."

**Councilor Rodden** reported the Recycling Committee was congratulated and has won the Eco Maine award for Falmouth. Discussion continued relative to a silver bullet audit. The Silver Bullet is the metal container that you put containers in. Containers are kept at the Bucknam Road Fire station and Hannafords.

The Board of Directors at EcoMaine have passed their budget and a 1.5% increase in assessments. Recycling revenues have gone up. Three was a fire in the recycling plant on Friday. It damaged some equipment.

**Councilor Armitage** reported that RACPAC is working on their mission statement. Tidewater Conservation is trying to address concerns and will possibly come back to the June meeting.

**Chair Breen** reported that GPCOG is a membership organization; rolling out three task forces: economy, environment and community. They are looking at regional planning and being respectful of home role and individual town needs. Looking at the mile high concept, a set of principals that member organizations agree to take on as they do their planning. Chair Breen stated the Governance Committee is working hard.

#### 3.14 <u>West Falmouth Crossing Master Planned Development District</u>\*

[Adopted, 1/26/98] [Amended, 12/22/05] \*(Formerly Exit 10 Master Planned Development District)

To create a planned development at the West Falmouth Crossing interchange that will be in keeping with the semi-rural character of West Falmouth and surrounding neighborhoods. To permit maximum creativity in site design and to ensure high quality construction with special attention to landscaping, lighting, building orientation and form, coordination of architecture, and signage. To accomplish these goals, the Town Council may approve a Master Development Plan that guides the site plan review process in keeping with general performance standards of the ordinance, but with more flexibility granted to developers and the Planning Board in implementing the approved Master Development Plan.
