## Town Council Meeting June 15, 2009 Minutes

#### **Roll Call**

Councilor Breen stated it was not necessary to do roll call because all Councilors were present and it had already been done in the prior session. The meeting started at 7:10.

#### **Public Forum**

Councilor Breen opened the Public Forum.

Willie Audet, 41 Merrill Road, spoke of his disappointment in the vote at the May 26 Council meeting and expressed that the Workforce Housing Committee had worked long and hard to find the correct solution for Falmouth. Mr. Audet hoped that the Council still had Workforce Housing on their radar and business plan. Mr. Audet referenced a headline in the Maine Sunday Telegram which was titled "Housing Costs Still Too High for Many." The Article listed Falmouth as number one for the highest median price in Cumberland County at \$405,000; Cumberland was second and Cape Elizabeth third. Mr. Audet explained he is presently working on a new plan and will introduce it to the Council and the Town. He also stated that he thought some Councilors considered the redevelopment of the school the solution, but the school would not be occupied for another two to three years. Mr. Audet stated the problems had been identified and they were working on them but unfortunately, the Woods Road project came to a stop. Mr. Audet clarified he was still just as determined to continue the work and he is a big believer in the Workforce Housing project. Mr. Audet spoke of the many conversations he had over the years and this is not just about the people living and working in Falmouth now, but also about the students who graduated from FHS who may not be able to come back to Falmouth to live after college. Mr. Audet spoke of the kids that do come back, and he referred to Councilor Libby serving the community as a Falmouth EMT volunteer for twenty years. Mr. Audet reiterated that he has not given up and he was very determined to have Workforce Housing and there was work to be done to convince the opponents that this is the right thing to do.

Mr. William Gardiner, Underwood Road, stated he had not planned to speak. Mr. Gardiner said he has known Mr. Audet for years and he appreciated the fact that Mr. Audet wants to have housing in Falmouth for people who do not want to spend \$400,000 or more. Mr. Gardiner stated it was very possible to do that in compact zoning which had been discussed in prior years, and by using the free market, but this will take sewer. This should not cost the taxpayers any money in taxes. Mr. Gardiner opposes spending close to 1,000,000.00 in subsidies, and said it does not need to be that much to have affordable

housing for EMTs and teachers. Mr. Gardiner stated that you cannot dictate that the housing be exclusively for employees of the Town. Mr. Gardiner acknowledged that the concept is great but the term "Workforce Housing" stands for subsidized housing. Mr. Gardiner refereed to the email sent from the developer to Nathan Poore which used the term subsidized housing. Mr. Gardiner claimed subsidizes housing has not worked around the country and that right now there were many homes in Falmouth on the market for 250,000,000. Mr. Gardiner commended the Council for their decision on the Woods Road property.

Councilor Breen closed the Public Forum. Councilor Breen encouraged the public to pick up the Town Report. The Town Report will be available at the Town Hall and the library as well as the website.

Councilor Breen asked Councilor Pierce to come to the podium to announce the resolutions.

Councilor Pierce explained she was the liaison for the School Board and Falmouth was very fortunate to have so many State Champions. Councilor Pierce invited the representatives from the Theater Company to come up to the podium to accept the Resolution from the Council.

In METRO news, Councilor Rodden reported that there have been 54 ten-ride passes and 124 monthly passes given to the citizens of Falmouth. The 10 ride passes are courtesy of Falmouth by the Sea and the monthly passes have been donated by METRO.

Councilor Armitage reported the next meeting for the One Falmouth Committee would be held on June 25 at 2:00 p.m. in the upstairs conference room at Town Hall.

Councilor Breen reported the Community Facilities Planning Committee would also meet on June 25 in the upstairs Conference room at 7:00 pm.

Councilor Pierce thanked all the students who were present to receive their resolutions. Councilor Pierce explained that the wood chip boiler and the fields behind the Superintendent's office will be started this summer. The Green Ribbon Commission will be making a presentation in July.

Councilor Pierce moved to accept option B to amend the fee schedule for disposal of items at the Transfer Station, in accordance with Falmouth Code of Ordinances Chapter 13, Sec. 13-12 Schedules of charges for disposal. Councilor Libby seconded. Motion carried 7-0.

Item 11 Introduction of an amendment to the Falmouth Code of Ordinances, Chapter 17, Traffic and Motor Vehicles, Article III, Section 17-92, (a), to add new language as follows: "Johnson Road, from the west end of the municipal parking lot (at the intersection of Route 88 and Johnson Road) to the intersection of Bartlett Way."
