Gerry: Page 7: Septic Permit: is that revenue into the plant? What is #8?

SCHOOL REPORTS

Steve Welford update: Still waiting to hear from the State; adjust out our aid April 1 and last month. Not sure of the deductions. No numbers are valuable for rev. or expenditures

Freeze on December 1st, freeze is now. Maybe making up 400,000 rev.

Brian: legally is off/legal actions 3 collective bargaining's, purchases page 24, purchasing sales 635

line: need to find out.

Page 25, 642: salaries subs for district, what are the district custodians.

Steve: Subs ill and retirement higher use if subs than normal.

Jodi: page 2-unemployment. The line is estimated. Last year \$15,000 with some lay off 6 teachers and one para.

Brian: Are we liable for someone getting laid off at another job? Steve: We are responsible for people who didn't work for this year.

Discussion on heating oil and snow plowing.

Discussion on copier lease:

Steve: copy lease service, new lease with new contract. The service contract is less. We will be on the positive with new contract.

Brian: Food service? Any projections?

Steve: 35,000 is charge for service. They are satisfied they are making adjustments first year and

usually profit.

Brian: How does this compare:

Steve: totally cost \$35,000. We now have on line payments. We have a new policy for people who

have charges.
