2. **New Member**: Gail welcomed Bill Tsiros to the committee. He provided his contact information.

- 3. **Review of April 8th minutes**: Ann moved to accept and Elaine seconded. No discussion. Vote taken six approved and one abstention. A secretary was hired and she will be here for the June meeting.
- 4. **Review of Sarah Greenfield Sign:** Gail forwarded Keith's email to Renaissance Signs for a quote for the sign. Our budget is \$3,500. Brian will check on whether we need additional quotes. Gail is under the impression that EDC needs to make a recommendation. Bill asked about reason for new sign and we need try to find other ways to attract businesses. Suggested having more money to have town planner to attend meetings in Concord to attract businesses such as manufacturing, warehousing, etc. A study to decide what to do next. It was asked if the job description includes economic development. We as an EDC provide advice on having a staff member do ED. Other options were discussed. Regarding the sign, Gail reported on the condition of the existing sign. We are recommending the same size with granite post. Bill mentioned there is a sign business on Charles Street.

5. **New Business:**

- a. New Business Ribbon Cutting: Shear Heaven Salon is owned by Jackie Nesbitt. Ann is trying to arrange a ribbon cutting and will let us know. Business is already open.
- b. Interest in Sarah Greenfield: A business has expressed interest in one of the parcels. Brian said the Selectmen do not know who it is.
- c. Planning Board: Interest was expressed about the importance about having a Planning Board member attend EDC meetings. Gail said they had previously declined. There was additional discussion. Bill suggested a letter to the Selectmen and Planning Board asking them to appoint a

- b. Christmas lights/trees: Brian said Keith has contacted PSNH and they said no. However there is a way to get a special exemption if the Town accepts responsibility for the lights. Regarding the trees, Brian said Tom was at the Selectmen's meeting. Tom is getting quotes for twenty four of them.
- c. Town owned properties: At the April 14th BOS meeting they approved the absolute auction of all of town owned properties on South side of Rte 11, except a couple of parcels the town uses.
- d. Town Website/EDC Page Update: Megan has done some updates since the meeting with Joan, Kathy and Denise. Today Denise provided her with proposed changes and she is working on them. Hope to have the designated Economic Revitalization Zone maps in a printable format and need to follow up with Kathy regarding these. Looking at the ERZs via Google Earth is good but having a printable version in needed. Being able to have the designated ERZs, FAQ sheet and Business Application for the tax credit available on the website is important. Hopes to have this added by next meeting.
- e. Adopt a Spots: Gail asked who was in charge. Ann is going to ask Megan for a list.
