BOARD OF SELECTMEN MEETING MINUTES

November 5, 2012

CALL TO ORDER: Betsy called the meeting to order at 6:03 PM.

Appointments

1. Waste Disposal Committee – Becky stated the Committee requested the meeting with the Board to discuss painting the buildings at the Transfer Station. The Committee would like to purchase the paint with remaining funds. The Board discussed trying to store the paint for the winter in the Highway Garage. The Committee is also requesting to purchase a weed-whacker that is suitable for the Transfer Station's needs, which would cost about \$500. Mike stated that there are some facility improvements that the Board had discussed trying to address this year. Scott explained to Becky and Sarah some of the issues that the Safety Committee had identified. The Board decided to buy the paint now and hold off on the weed-whacker until they see how much the other expenses cost.

New Business

The Board discussed that Moderator Paul Lawrence had requested that the Police Department only have officers at the election on November 6 from 7 AM to 8 AM and then check in periodically. Betsy said she had told Chief Bell this recommendation and Chief Bell thought it was a mistake. The Board agreed to follow the Moderator's recommendation.

The Board reviewed the proposed website page for assessing information and approved it with an addition of the Town's Assessed Valuation.
