## **BOARD OF SELECTMEN MEETING MINUTES**

## June 2, 2014

**<u>CALL TO ORDER</u>**: Betsy called the meeting to order at 6:30 p.m.

#### Appointments

1. Bruce & Danielle Harrington – Bruce explained his frustration with the letter that was sent regarding the detour for the bridge construction and the number of people getting lost because of the current signage for the detour. There was a discussion about adding more signs. The Board agreed to talk to the Engineers regarding moving/adding signs.

Betsy stated we have some abatement recommendations but in the essence of time we will wait until next week to review them.

- Crotched Mountain Rehab PILOT Discussion there was a discussion regarding moving forward with a PILOT program. Scott said he thought the Board should meet with Crotched Mountain. Abigail said she would like to see the Town treat them as tax exempt going forward with no PILOT program. Betsy agreed with Abigail.
- 3. Mike asked the Board if they would like to revisit the no parking zone by the boat launch on Pleasant Pond Road that they had discussed last year. Betsy said she understands there would have to be a public hearing on a "no parking" ordinance to be able to install "no parking" signs. The Board agreed to look at the area independently and for Mike to get the opinion of the Road Agent, Police Chief and Fire Chief.
