## August 21, 2012 MINUTES

Planning Board Members Present: L. Kunhardt, B. Lindgren, M. Tartalis, A. Arnold, P. Tollman.

The meeting was brought to order at 7:02 pm.

### Announcements and Communications

Kunhardt updated board on the status of the DES maps. Kunhardt has received the DES digital maps of the aquifers and existing wellheads.

H. Camirand and L. Ames join the board at 7:05 pm.

Kunhardt will forward e-copies to the board and expects NHDES to send a print copy.

At the last Selectmen's meeting, Peter Hopkins (town building inspector) suggested the board discuss the ongoing use, by residents, of plastic structures --- garages, storage structure, etc. Hopkins expressed concern about safety, and he has no authority to approve them. However, he continues to receive requests to approve them. Board discussed the issue briefly and will place the matter up for discussion on the next agenda.

Building Inspector also requested the board look at timely renovations of buildings. Specifically of concern are the buildings at the golf course. If renovation does not take place, when do such buildings become a safety hazard?

A. Arnold was also asked if there could be an ordinance requiring Main Street residents to keep their yard in order.

Brief discussion about regulations covering abandoned buildings and temporary structures.
