12-3-13: Motion to accept as presented, Camirand, 2^{nd} Pyle. Motion passed, Tolman abstains.

12-4-13: Motion to accept as presented, Camirand, 2^{nd} Pyle. Motion passed, Tolman abstains.

12-10-13: Insert under "New Business" Board received a draft copy of the Master Plan update for Community Facilities. Correct spelling for "Priest" is "Preece." Motion to accept as amended, Camirand, 2nd Pyle. Motion passed, Tolman abstains.

Unfinished Business:

Farm: Insert definition for farm. Motion by Camirand to accept the change. 2nd Tolman. Motion passed 7-0.

Farm Roadside Stand: Add to definitions. Motion by Camirand to add arm Roadside Stand to definitions. 2nd Tolman. Motion passed 7-0.

ICC: Insert ICC in place of BOCA. Motion by Pyle to insert ICC. 2nd Camirand. Motion passed 7-0.

Manufactured Home: Insert manufactured home in definitions. Motion by Pyle to insert manufactured homes in definitions. 2nd Camirand. Motion passed 7-0.

Remove Mobile Home from ZO: Motion by Pyle to remove mobile home from ZO. 2nd Camirand. Motion passed 7-0.

Remove Roadside Produce Stand from ZO: Motion by Tolman to remove roadside produce stand from ZO. 2nd Ames. Motion passed 7-0.

Structure: Remove mobile home and replace with manufactured homes. Motion by Camirand to change language. 2nd Pyle. Motion passed 7-0.

New Business:

Sign Zoning Ordinance. Camirand recuses himself. L. Borbeau provides the Board with an overview. Discussion ensues regarding the proposed changes and additions to the ZO. Discussion ensues regarding content and how signs are treated.
