CIP Meetings(cont.)

Police Department – Steve Bell

Scheduled replacement of the Tahoe in 2017 will be ~\$55K (up from\$40K) due to additional fitting costs (cages and electronics) FPD still needs at least one vehicle with towing capacity. The possibility of increasing contribution to reserve fund to cover increased vehicle costs is discussed.

Chief Bell responded to a question from Ames that he would like some help planning renovations to the Town Hall Annex if the police department is to be staying there.

Bell is still looking for grant money for traffic counters.

Highway Department – Gary Paige

Vehicles, prices based on previous estimates plus inflation:

Payloader (2016) - \$180-200K

6 Wheel Dumptrucks (2018 & 2019) - \$200K & \$225K

P/U Truck (2019) \$55K

Will look into availability, price, and appropriateness of surplus/used vehicles.

Bridges: Scobie Pond Road bridge condemned by state, construction of replacement bridge to begin October 27.

Juniper Hill Road and Woodward Hill Road bridge reconstruction in 2015

Roads: Discussion of doing major road work every other year at funding level of \$170K/yr to take advantage of economies of scale. Current road priorities are to finish Pleasant Pond Road, then Bible Hill Road from Rte 136 to the mailboxes, then Woodward Hill Rd. Gary anticipates upcoming road reconstruction not to be as extensive as Pleasant Pond Rd to date, requiring only grinding and reuse of existing pavement, adding 3/4" stone, and paving.

Discussion ensued as to whether the last portion of Pleasant Pond Road ought to be paved or not and alternate maintenance options for that section of road.
