## 2. Guests/Presentations:

a. Retirees: Mrs. Sabolinski, Mrs. Mullen, Mr. Creedon and Mrs. Grady took this time to recognize this year's retirees who have given so much of their time to the Franklin Public Schools. They also recognized the assistant principals from the high school who are moving on to new positions next school year. Mrs. Sabolinski noted she is sad to see them go and notes they will always be a part of the Franklin Public Schools family. Mrs. Trahan added that she wishes them all the best of luck. For those retiring, it is bittersweet - while it is a time of leaving it is also a time of new beginnings. Mrs. Mullen wanted to wish them all best wishes as they continue on their journeys.

b. ECDC Update: Mrs. Kelley, Director of ECDC, gave an overview of the school year. She noted the mission was to strengthen community on the quest to improve quality. All classes now start at 9:15 a.m. which allows families the opportunity to network with all ECDC families. Several programs were piloted such as the summer inclusion program and the extended a.m. session during the school year. She also noted how all classes now do the same theme at the same time which allows for a more collaborative approach to teaching and learning. The structure of the open house was restructured where learning is now showcased and parents interact with their children at different stations to understand what is being taught. Communication with families has increased as she now provides families with regular e-mail updates. Going forward, she would like to transition into a blog format of communication. Lastly, she noted she has challenged her staff this year and she is excited about where they can go from here. Mrs. Rohrbach stated it was a fabulous PowerPoint and presentation. She
stated it is very apparent at how well you've done in terms of unifying the school - so nice job.
c. Horace Mann Update: Mr. Fortin, Mr. Schliefke, Mrs. Forman and a few students spoke to the Committee regarding field trips students took that support and nurture STEM. Mr. Schliefke noted how he challenged the science department to create small scale field trips that expose students to real world science while also getting students excited about science. Students took field trips to the following locations: Boston's Museum of Science, an MIT lab, the Mystic Aquarium, Harvard's Museum of Natural History and Signal Rock Farm. Students discussed these trips and noted how they were exposed to and learned about the classification of animals, climate change, genetics and sustainable farming to name a few. Mr. O'Malley noted the student presenters were outstanding. He applauds the idea of field trips adding it is an important tradition of our schools. Mr. Jewell is excited to see the kids exposed to such amazing sciences at such a young age.
