He would like to continue to increase access, program offerings and performance. With regards to the School Improvement Plan, he noted that the MCAS goals are more broadly structured. He also discussed four target areas: Literacy Instruction, Math Instruction, Social \& Civic Competency/Community Partnerships and Blended Learning.
