Franklin School Committee Minutes

October 25, 2011

Call to order: 7:00 p.m. Mr. Roy
Mr. Roy read the Districts Vision and Mission Statements. The Vision Statement reads the Franklin Public Schools will foster within its students the knowledge and skills to find and achieve satisfaction in life as productive global citizens. The Mission Statement reads the Franklin Public Schools, in collaboration with the community, will cultivate each student's intellectual, social, emotional and physical potential through rigorous academic inquiry and informed problem solving skills within a safe, nurturing and respectful environment.

Mrs. Douglas reviewed the payroll, found it to be in order and recommended acceptance.

- FHS Student Representatives: Sarah acknowledged the girls cross country, field hockey, volleyball and soccer teams who all won Hockomock championships. She also mentioned the High School is trying to start a new traditional - a school wide tailgate - for the last home football game. Susan noted that an informal survey has been conducted on the food services program and she stated that Panther Pride night was very successful.
- Correspondence: Mr. Roy acknowledged the letter from the FEA and noted that Interest Based Bargaining is being used to negotiate a new contract.


## 2. Guests/Presentations:

a. School Improvement Plans: The principles from the Kennedy, Jefferson and Parmenter elementary schools were on hand to share with the Committee their school's improvement plans. Each school continues with the Literacy Initiative goal this year and will implement the new phonics program Fundations as well as writers workshop. Each school also continues to work on the Response to Intervention goal, will recommit to the Open Circle Program as a means of teaching social skills, and will continue to focus on making gains with students who struggle in math, as well as school specific goals.

A five minute recess was taken.
b. Performance Based Evaluation Pilot: Chandler Creedon, President of the FEA, and Donna Grady, Vice President of the FEA, joined Mrs. Sabolinski and Mrs. Winslow to give an overview of the Performance Based Evaluation Pilot Program. They noted that the 'old' evaluation process gave way to a sense of distrust and feel this new paradigm creates a more collaborative work environment between teachers and administrators. Historically, evaluation systems focused on the teacher and not on the student learning outcomes. This will change with the new system. Teachers will be assessed based on student performance. This program will become effective across the State in 2013.

- School Committee Calendar Change: Mrs. Mullen noted that the School Committee meeting scheduled for November 29th has been moved to November 15th. On November 29th and December 6th, the School Committee, along with the FEA, will participate in an Interest Based Bargaining training.

the new High School building project, implement and supervise the new Performance Based Evaluation Pilot Program, look into more blended and online learning programs for students, and develop a School Committee website. - School Committee Liaison Reports: Mr. Cafasso noted that the School Building Committee met last evening. He noted that the next meeting is scheduled for November 14th at 7 p.m. A community wide meeting will take place at the Horace Mann auditorium on November 17th which will provide an update to the community on the project. Mr. Roy noted that the Bullying Task Force also met last evening to discuss how the policy is working. He noted that overall, it is quite favorable.

- Mrs. Trahan noted that the annual Casino Night will be held on Saturday, November 5th. She also noted that the Kennedy School's fun run is this Saturday, October 29th at 9 a.m.

Mrs. Mullen presented both Mr. Roy and Mr. Glynn with a gift from the School Committee as both are not seeking re-election for their positions on the School Committee. She noted the innumerable hours they have served and thanked them both for the service they have brought to the School Committee over the years.
