Mrs. Mullen read the Districts Vision and Mission Statements. Mrs. Douglas reviewed the payroll, found it to be in order and recommended acceptance.

- FHS Student Representatives: Sarah noted that thus far, five seniors have signed Letters of Intent to play sports at Division I colleges. She also noted that report cards will be given out tomorrow and the second semester has started. Lastly, she mentioned that the Middle and High School Music Departments will perform a concert hour at Dean Chapel both this evening and Thursday evening at 7 p.m. Susan noted that Mr. Light would like to begin creating a video archive of seniors for faculty with hopes of measuring yearly change. She also mentioned that the student government is hosting the Winter Carnival on March $11^{\text {th }}$. This year, the carnival will sponsor Tickets for Loving Children (TLC) which provides entertainment packages to hospitalized children.

## 2. Guests/Presentations:

a. Horace Mann Middle School Update: Mr. Fortin, Sharon Jackson and two HMMS students showed a video to the Committee on the Specials offered at the school - such as Tech Ed, Phys. Ed, Spanish, Art and Chorus. It was noted that specials help increase creativity in our schools. Mrs. Rohrbach noted the importance of the unified arts and how it helps educate the whole child.

A five-minute recess was taken.
b. Special Education Update: Beth Fitzmaurice gave the Committee an update on Special Education. $14.6 \%$ of students within the District have mental health challenges that prevent them from accessing the curriculum. The challenges faced are that special education is not fully funded. Out of District tuitions and transportation costs are on the rise. The District will continue to work hard to meet the needs of the students with decreasing revenues. They will also continue to evaluate the program to assure efficiency and efficacy of services provided.
c. New Head Injury Policy Presentation: Mrs. Winslow noted that this initiative is driven by the frequency of head injuries across the Commonwealth and impacts all students in grades 6-12. She stated that the focus is on the prevention, training, management and return to activity decisions regarding students who incur head injuries in extracurricular athletic activities. We will begin utilizing the DPH required forms and implementing the training requirement this spring sports season. It was noted that we already have a policy in place - Policy JNN.

## 3. Discussion Only Items:

- Student Conduct Policy Changes: There was a first reading for the Policy JAB which is a new policy. There was a first reading for Policy JIC which has significant changes and there were first readings to eliminate some policies. Mrs.

Winslow noted that some policies were redundant and were already in the handbook. She noted that the way to go is to move toward broader policies.

Mrs. Rohrbach noted that the Joint Budget sub-committee had a great kickoff meeting - which was primarily organizational. They plan to meet every six weeks.
